145. Crash Description/Narrative

A motor vehicle collision occurred in the intersection of Route 88 and Jack Martin Boulevard. Vehicle 02 was traveling on Jack Martin Boulevard south bound and attempted to make a left turn onto Route 88 east bound when the traffic signal turned green. Vehicle 01 was traveling straight ahead on Route 88 west bound approaching the intersection with Jack Martin Boulevard, failed to observe the traffic signal turn red, and entered the intersection while vehicle 02 was making its left turn. Vehicle 01 attempted to swerve to the right but the front end of vehicle 01 struck the driver side middle of vehicle 02.

While on scene, there were no reported injuries and all parties declined medical attention.

Driver 01 stated he was traveling on Route 88 west bound approaching the intersection with Jack Martin Boulevard. Driver 01 advised he looked down to check his equipment on the front passenger seat and when he looked up, he observed the traffic signal for the intersection had turned red. Driver 01 explained he applied his brakes and attempted to swerve to the right to avoid a collision with vehicle 02 but was unable to do so in time.

Through my investigation, I find driver 01 at fault for disregard of a traffic control device and driver

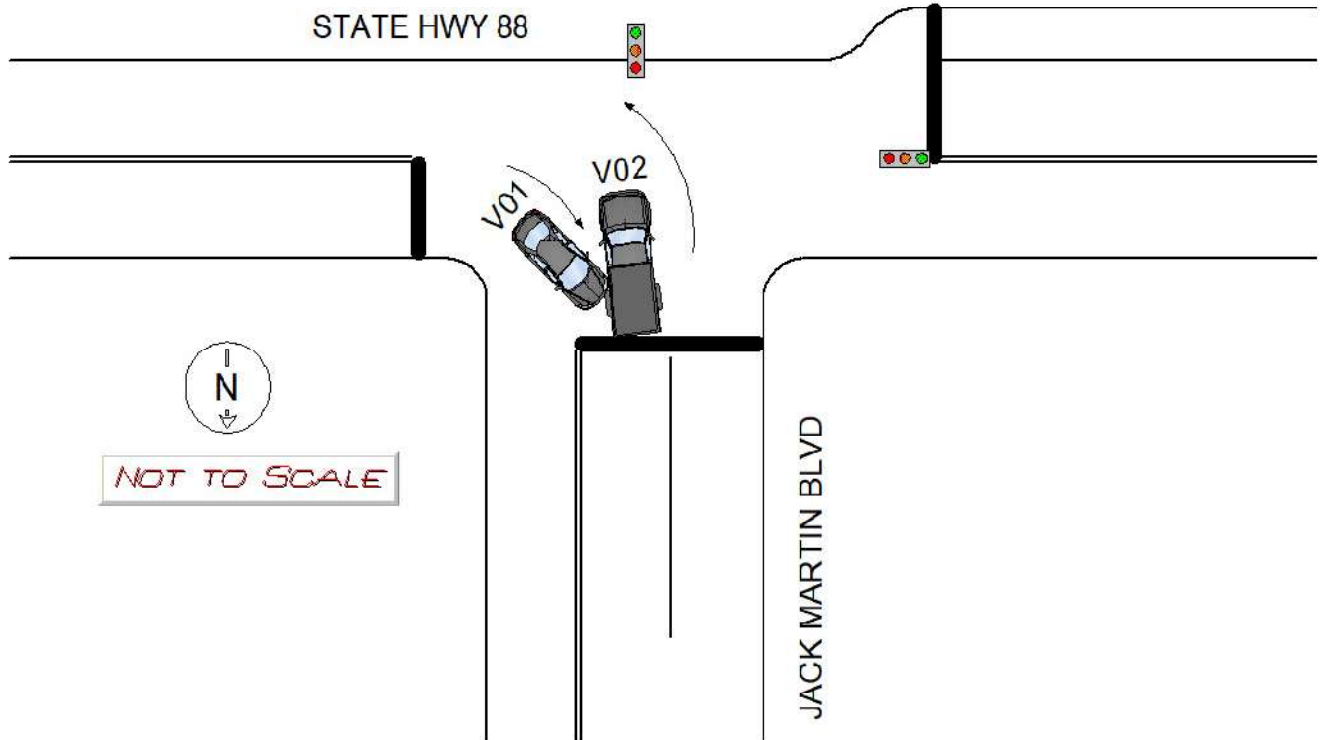
