145. Crash Description/Narrative

Vehicle 1 was in the Auto Zone (2160 Route 88) facing south, attempting to exit the parking lot onto Route 88.

Vehicle 2 was directly behind Vehicle 1 stopped in traffic. Vehicle 1 slowly started to back up and backed into Vehicle 2.

In speaking with the driver of Vehicle 1, he stated he was in the parking lot getting ready to exit onto Route 88.

Driver 1 stated he thought he was a little to far into the roadway and saw vehicles coming so he decided to back up. Driver 1 explained his vehicle is manual and as he was backing up his vehicle stalled on him while backing up. Driver 1 stated he attempted to get his vehicle running again but was not able to in time and backed into Vehicle 2.

In speaking with the river of Vehicle 2, he stated he was stopped directly behind Vehicle 1. Vehicle 1 all of a sudden started backing up and backed up directly into Vehicle 2.

Vehicle 1 had minor damage to the rear driver side bumper while Vehicle 2 had the front license plate ripped off with minimal damage. Due to the facts of my investigation and the statements made by the drivers, Vehicle 1 is at

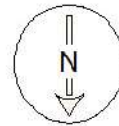
