145. Crash Description/Narrative

My investigation revealed the following: Vehicle 1 was attempting to make a left turn from the parking lot of 1608 RT-88. Vehicle 2 was traveling westbound on RT-88. Vehicle 1 failed to yield to the right of way of the other vehicles in the roadway. When vehicle 1 entered the roadway after failing to yield to the other vehicles he contacted vehicle 2. Vehicle 1 contacted vehicle 2 on the right front side of vehicle 2.

Driver 1 stated he was at a complete stop and when he attempted to enter the roadway, he never saw vehicle 2. Driver 1 stated vehicle 2 must have been speeding because he never saw vehicle 2. Driver 1 advised there was no way he was at fault because he was at a complete stop.

Driver 2 stated while traveling westbound on RT-88, vehicle 1 pulled out directly in front of her. Driver 2 advised vehicle 1 stopped before entering the roadway completely but was still about halfway into the travel lane. Driver 2 stated she was unable to get out of the way before vehicle 1 contacted her.

Vehicle 1 was determined to be at fault for not yielding to the right of way, and received a summons for careless driving.

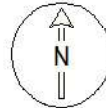

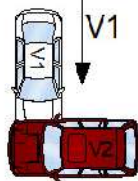
