145. Crash Description/Narrative

A motor vehicle hit and run crash occurred on Route 88 at the intersection to Old Squan Road.

Driver of Vehicle #2 advised she was traveling west on Route 88 towards Old Squan Road. Driver #2 advised she observed Vehicle #1 traveling on Old Squan Road towards the stop sign. Driver #2 advised Vehicle #1 did not stop and struck the rear passenger door and tire of her vehicle. Driver #2 traveled forward to move into the shoulder in front of 1930 Route 88 and observed Vehicle #1 turn right onto Van Zile Road and leave the area.

Vehicle #2 had damage to the rear passenger door and tire. Vehicle #1 possibly had damage to the front driver side bumper or fender.

Driver #2 advised she believed the vehicle to be a black 4 door car. She did not see who was driving the vehicle because they turned onto Van Zile Road before she could move into the shoulder.

Vehicle #1 failed to come to a stop at the stop sign of Old Squan Road and Route 88, striking Vehicle #2 which was traveling straight on Route 88.

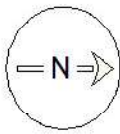

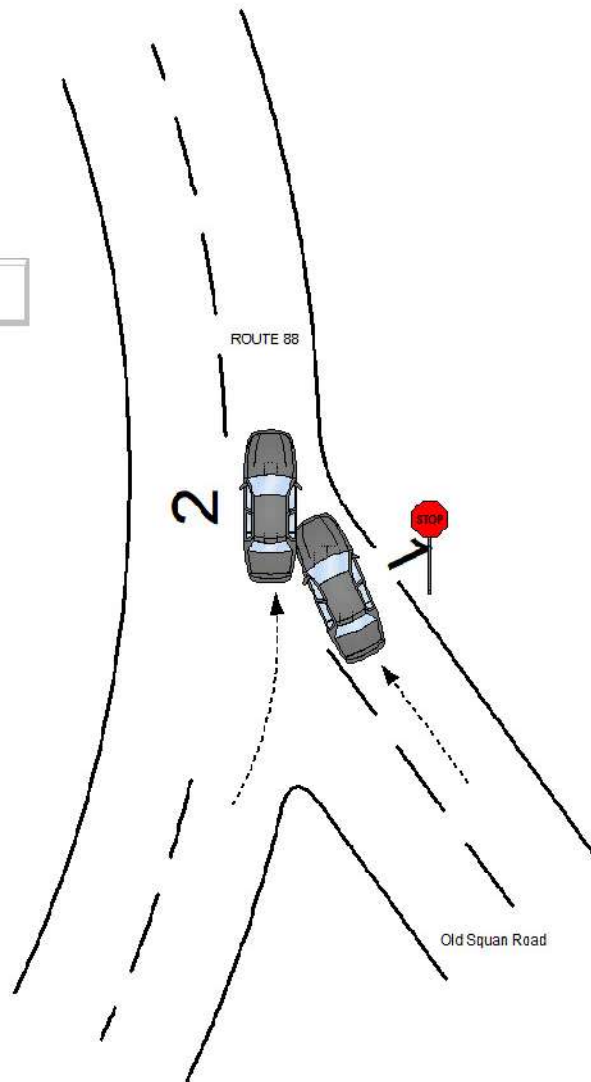
144 Crash Diagram (NOT TO SCALE)
