145. Crash Description/Narrative

V2 was traveling eastbound on Rt. 88 approaching the intersection of Midstreams Pl. V1 was traveling northbound on Midstreams Pl., stopped at a stop sign at the intersection of Rt. 88.

V2 had its right turn signal on as it approached the intersection of Midstreams Pl. in order to turn into a parking lot east of the intersection. V1 attempted a left turn onto Rt. 88, anticipating that V2 might be turning right onto Midstreams Pl. V2 did not turn onto Midstreams Pl. and continued past the intersection (for the right turn after the intersection) and V1 struck V2.

D1 stated he had assumed V2's right turn signal was for a turn onto Midstreams Pl. and he began his left turn onto Rt. 88, striking V2. D2 stated she was traveling past the intersection in order to turn into the next parking lot. She had her right turn signal on as she passed through the intersection when V1 struck her vehicle.

Both vehicles were moved prior to my arrival.

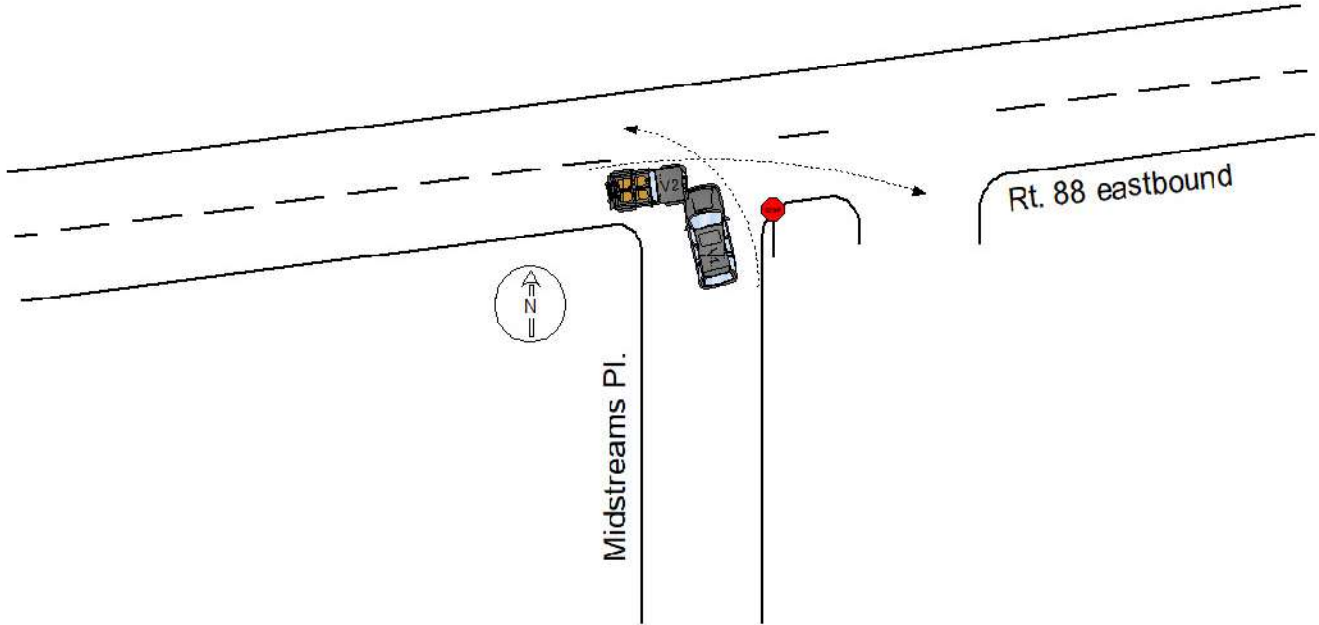
