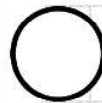

145. Crash Description/Narrative

Vehicle two was stopped on Route 88, facing west, at the intersection of Midstreams, waiting for the signal to change. Vehicle one was traveling west on Route 88, failed to stop and struck vehicle two in the rear with the front of vehicle one.

Driver one stated that he was distracted by his passenger and was not observing the roadway. Driver two stated that she was stopped at the intersection of Route 88 and Midstreams Road waiting for the light to change.

Several occupants of vehicle two advised they are injured and Brick Police EMS responded. Driver two informed that she is feeling pain to her lower back and head. Driver two denied being transported by Brick Police EMS and had her son, who was not involved in the accident, transport her to Ocean Medical Center. Allison Hagan (rear passenger side occupant in vehicle two) advised she is experiencing neck pain and Alyssa Byrnes (front passenger in vehicle two) advised she is having lower back pain. Hagan and Byrnes were transported to Ocean Medical Center by Brick Police EMS.

Vehicle one displayed heavy front end damage and multiple airbag deployment. Vehicle one was disabled in the

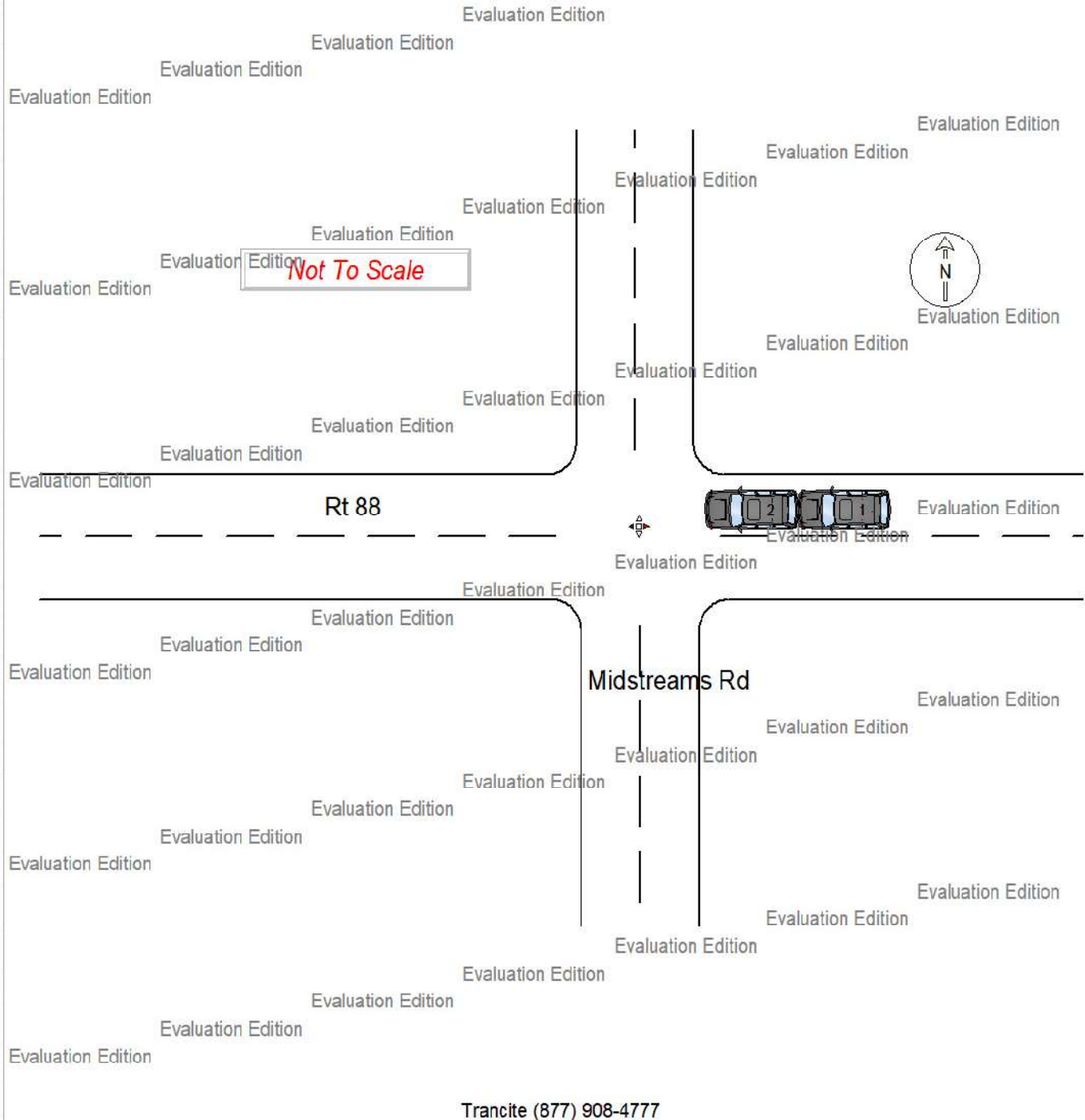
