145. Crash Description/Narrative

Vehicle #1 was traveling North on Jack Martin Blvd. Vehicle #2 was directly in front of Vehicle #1 attempting to make a left hand turn from Jack Martin Blvd. onto Burrsville Rd. Vehicle #1 struck the rear of Vehicle #2. I observed moderate damage to the rear bumper of Vehicle #2. Both vehicles were moved prior to my arrival.

Driver #1 stated she was traveling North on Jack Martin Blvd. and thought Vehicle #2 was going straight, never saw the vehicles turn signal and struck the rear of the vehicle.

Driver #2 stated he was stopped at the traffic light on Jack Martin Blvd. and Burrsville Rd. when the light turned green, he pulled up, turned on his blinker and was waiting for the on coming vehicles to pass to make the left turn. While waiting to make the left Vehicle #1 struck the rear of his vehicle.

My investigation revealed that Driver #1 is at fault for the crash due to her driver inattention and striking the rear of Vehicle #2.

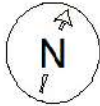

Motor Vehicle Crash Diagram

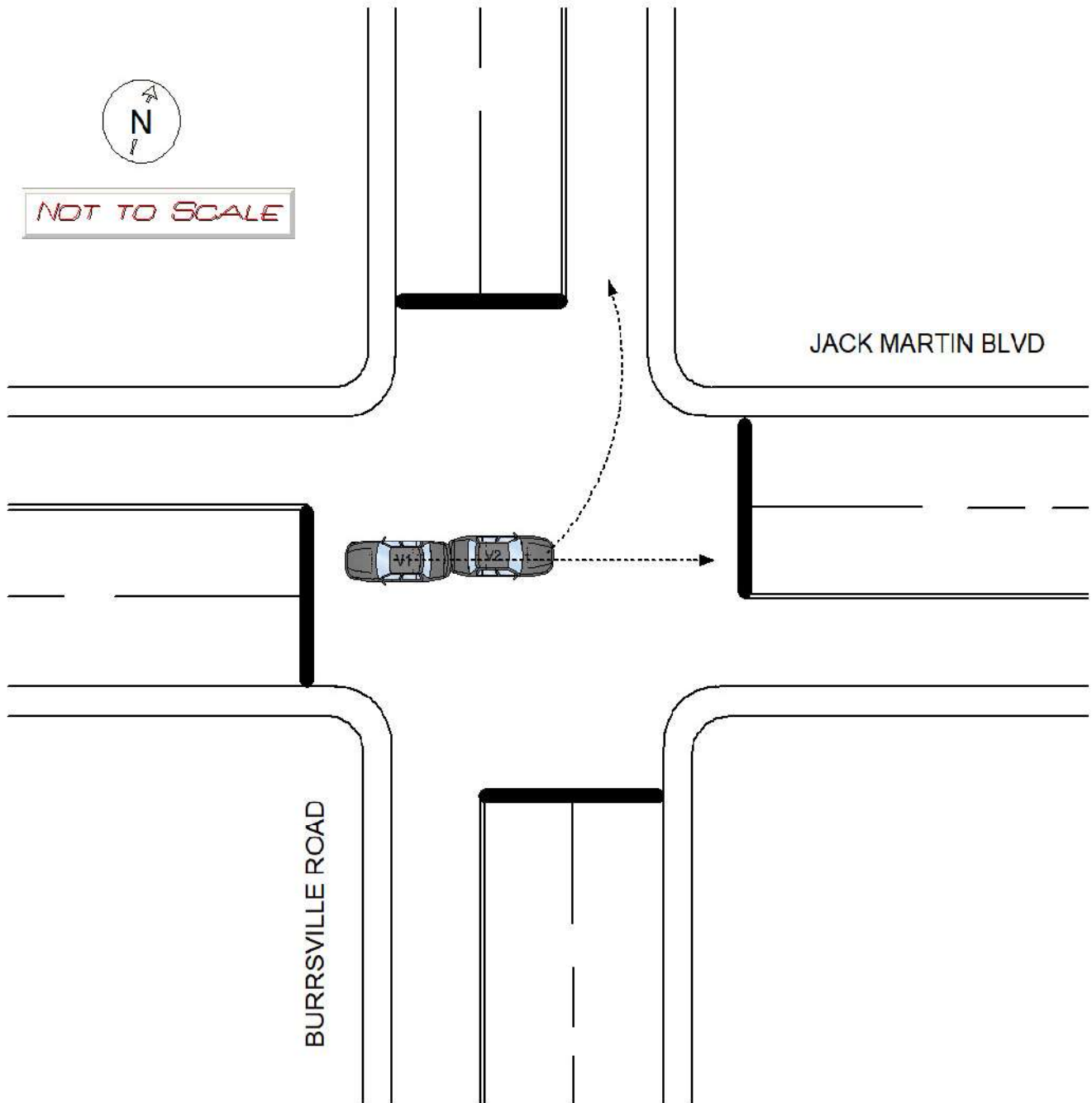
