145. Crash Description/Narrative

On scene investigation revealed vehicle 2 was stopped in traffic on Van Zile Road in the right lane. Vehicle 1 was directly behind vehicle 2, and the front of the vehicle struck the rear of vehicle 2.

The driver of vehicle 1 provided the following statement:

He was making a left out of the "Aldi's" plaza onto Van Zile and made his way into the right lane. He began to slow for traffic at the light for Route 70. As he got into the right lane a milk jug fell onto the floor by his feet. He reached down to grab the jug, while doing so he took his foot off the brake. As he looked back up he saw Vehicle 2 in front of him but did not have time to react and rear-ended the vehicle.

The driver of vehicle 2 provided the following statement:

He was in the right lane on Van Zile Rd stopped in traffic at the light to Route 70. He was able to see vehicle 1 prior to the crash through his rear view mirror and noticed the driver was looking down at something. He didn't believe the driver of vehicle 1 attempt to stop prior to the accident and it appeared vehicle 1 accelerated prior

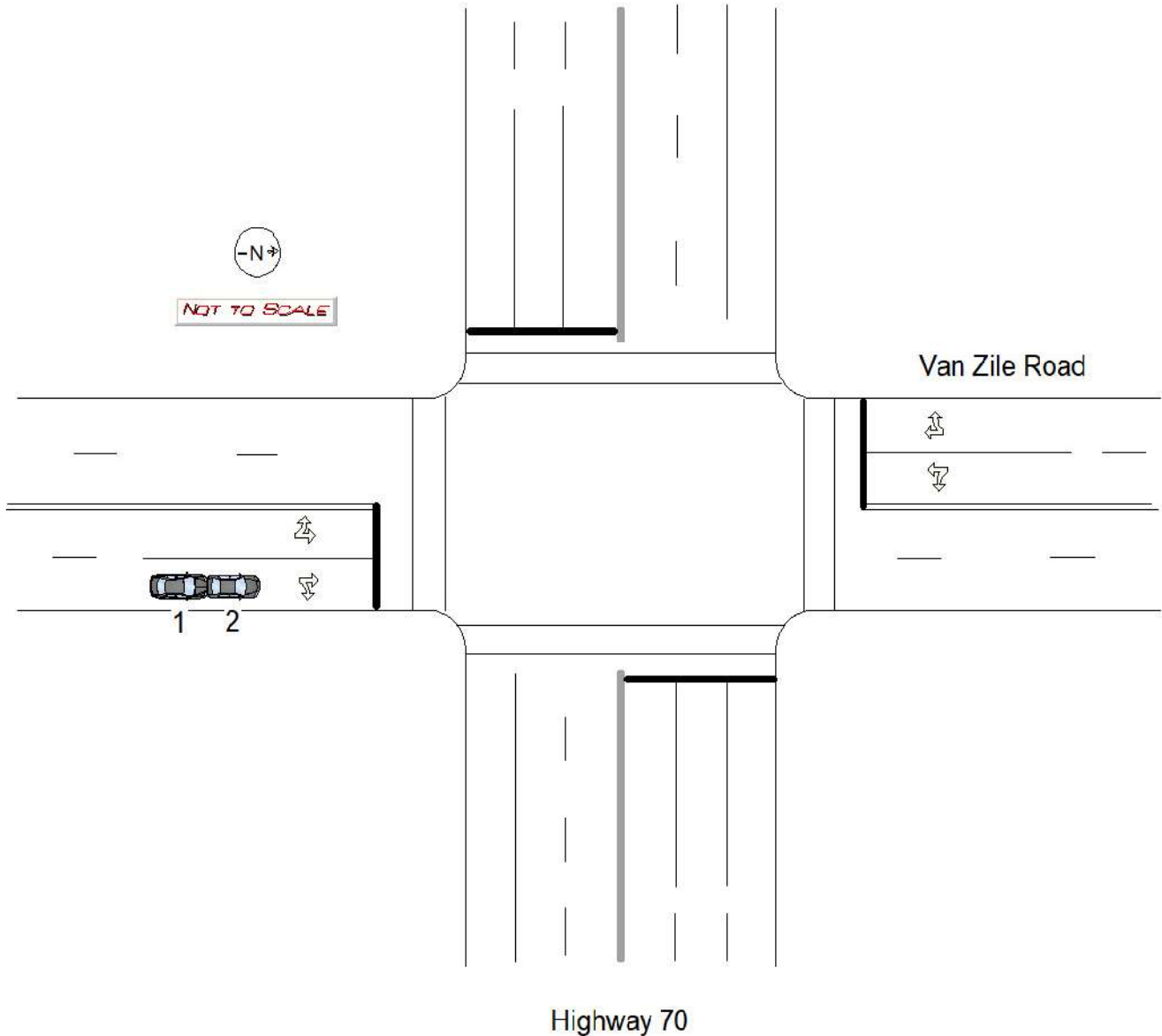
