145. Crash Description/Narrative

Vehicle 1 and Vehicle 2 were both traveling south on Jack Martin Boulevard in the area of Green Grove Road.

Vehicle 1 stopped to allow emergency vehicles, with their emergency lights activated, to turn into the parking lot of 515 Jack Martin Boulevard.

Driver 1 stated the following: he was traveling south on Jack Martin Boulevard, in the area of Green Grove Road. After moving over for the emergency vehicles, with their emergency lights activated, he continued down Jack Martin Boulevard. As he approached the area of 515 Jack Martin Boulevard he noticed Vehicle 1 had stopped in order to allow the emergency vehicles to enter the parking lot. Driver 1 attempted to hit his brakes and avoid the collision, but was unable to do so prior to striking the rear of the Vehicle 2.

Driver 2 stated the following: she was traveling south on Jack Martin Boulevard, in the area of Green Grove Road. She moved over for the emergency vehicles, with their emergency lights activated. Driver 1 reentered the roadway and believing the emergency vehicles were head to Ocean Medical Center down the road. When Driver 2 noticed the emergency vehicles were turning into 515 Jack Martin Boulevard, she applied her brakes in order to allow them to turn into the parking lot. When she slowed down she was rear ended by Vehicle 1.

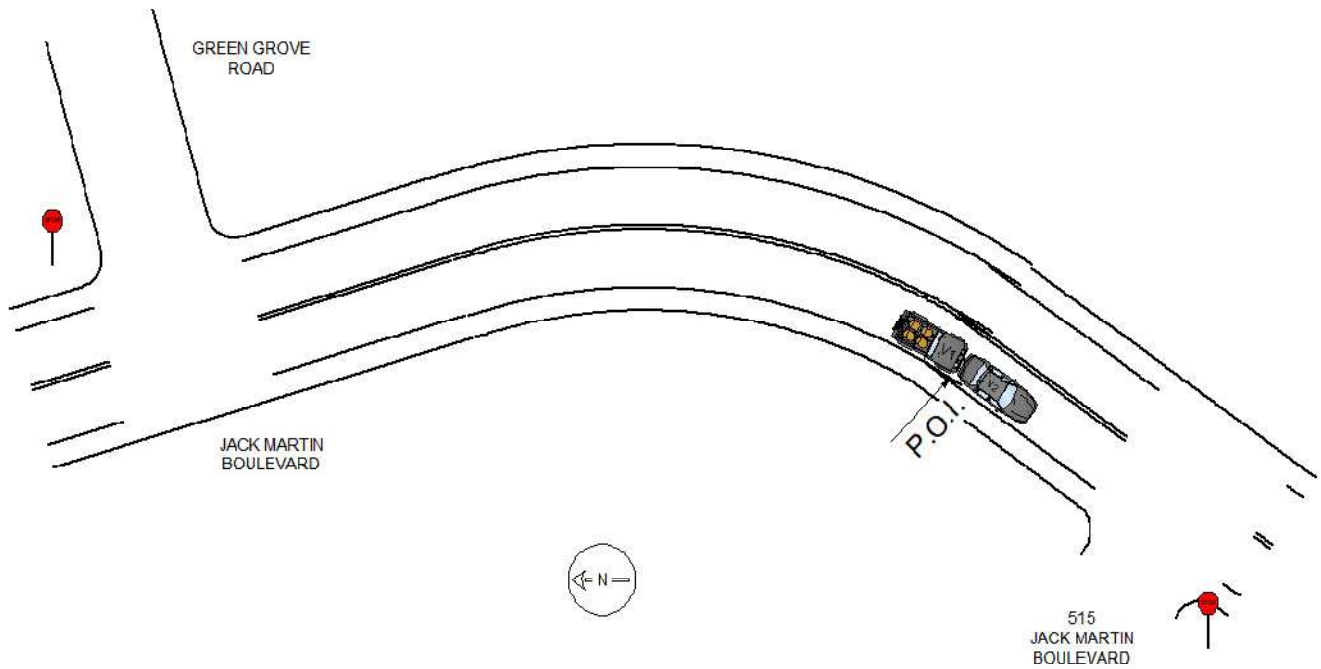
