145. Crash Description/Narrative

A motor vehicle crash occurred on Jack Martin Blvd approximately 25 feet east from the intersection of Burrsville Road.

Driver 1 stated that they were traveling westbound on Jack Martin Blvd when they changed lanes into the right lane. Driver 1 stated that they not see Vehicle 2 in their path of travel and impacted Vehicle 2.

Driver 2 stated that they were traveling in the right lane on Jack Martin Blvd when Vehicle 2 crashed into the side of them.

There was moderate damage to the passenger side of Vehicle 1 and the driver side of Vehicle 2.

My investigation revealed that Vehicle 2 was traveling in the right lane on Jack Martin Blvd approaching the intersection with Burrsville Road when Vehicle 1 entered their lane striking Vehicle 2 on the passenger side.

Driver 1 caused the crash due to unsafe lane change and driver inattention. Driver 1 was issued citations for 39:4-88B Unsafe Lane Change and 39:3-4 Unregistered Vehicle.

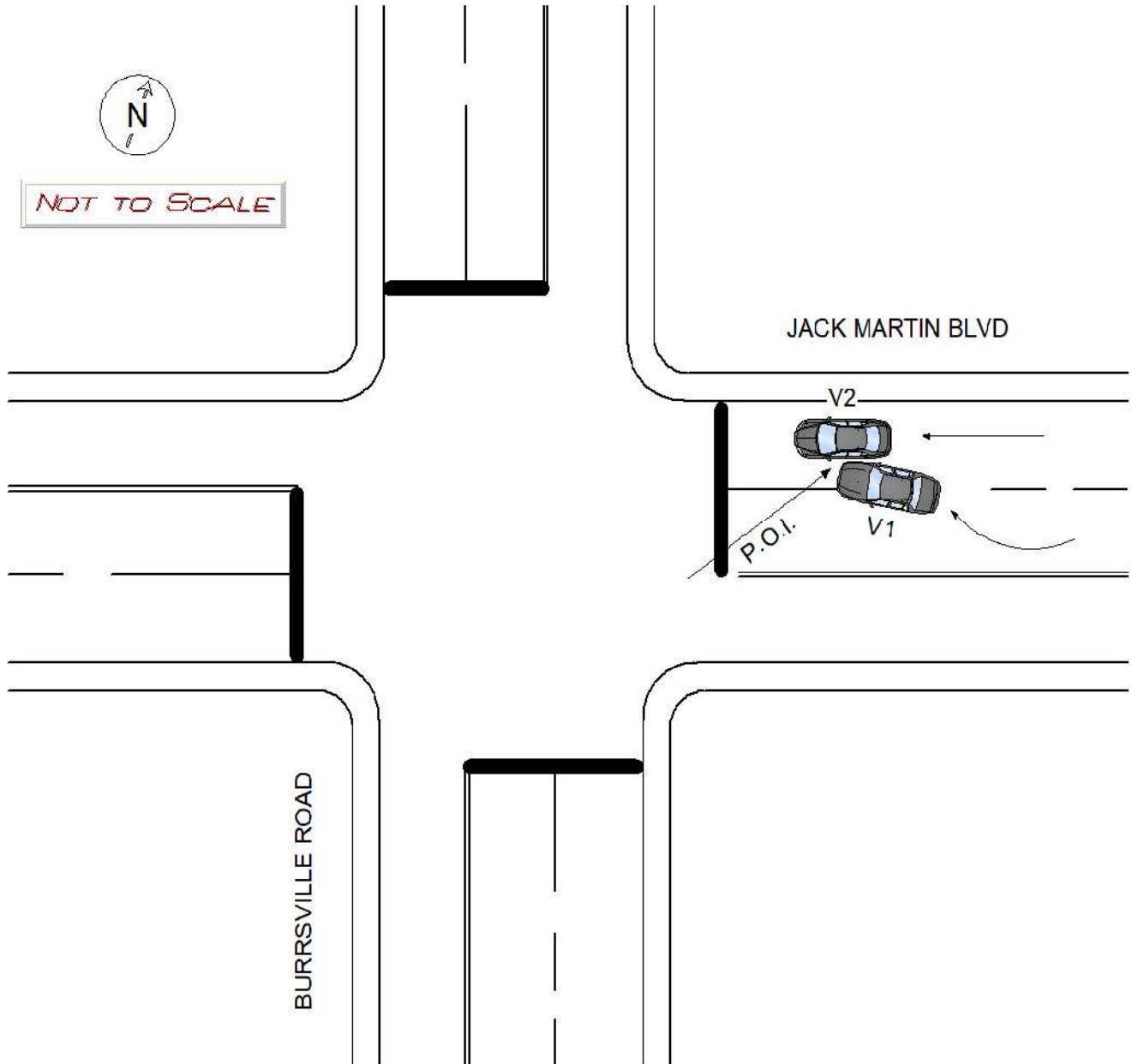
