145. Crash Description/Narrative

Vehicles 1 and 2 were located in the eastbound lane of State Highway 88, approaching the intersection of Folsom Drive. Vehicle 2 was stopped in traffic preparing for a left turn into the dentist's office located at 2024 Highway 88. Vehicle 1 was approaching Vehicle 2 from behind.

The driver of Vehicle 1 stated that Vehicle 2 stopped quickly, and he did not enough room to stop on the wet roadway with a car full of heavy construction tools. He then struck the rear of Vehicle 2.

The driver of Vehicle 2 stated she had been stopped in the roadway with her turn signal activated when she was struck from behind by Vehicle 1.

No injuries were reported at the scene. Both vehicles sustained moderate damage, but were still able to be driven safely from the scene. No motor vehicle summonses were issued.

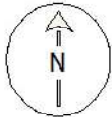
