145. Crash Description/Narrative

Crash investigation revealed that vehicle 2 was turning left from Route 88 onto Midstreams Place when vehicle 2 turned into vehicle 1 , hitting the front left side of vehicle 1 .

Driver of vehicle 2 stated that she was turning left onto Midstreams Place from Route 88 when she overturned and hit the front left side of vehicle 1 .

Driver of vehicle 1 stated that he was stopped at the stop sign on Midstreams Place, waiting to make a left turn onto Route 88. He further stated that while waiting to make the left turn, vehicle 2 made a left turn onto Midstreams Place from Route 88 and the front left side of vehicle 2 hit the front left side of his vehicle (vehicle 1).

On scene, I observed moderate damage to the front left side and the middle left side of Vehicle 2. I also observed minor damage to the front left side of vehicle 1 .

Upon asking, both drivers stated that they were not injured from the crash.

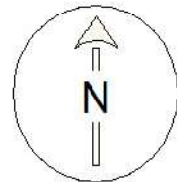
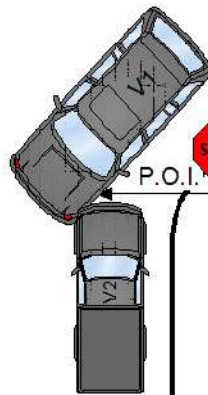
