145. Crash Description/Narrative

vehicle. Vehicle#1 was not moved prior to arrival. Driver#1 refused first aid.

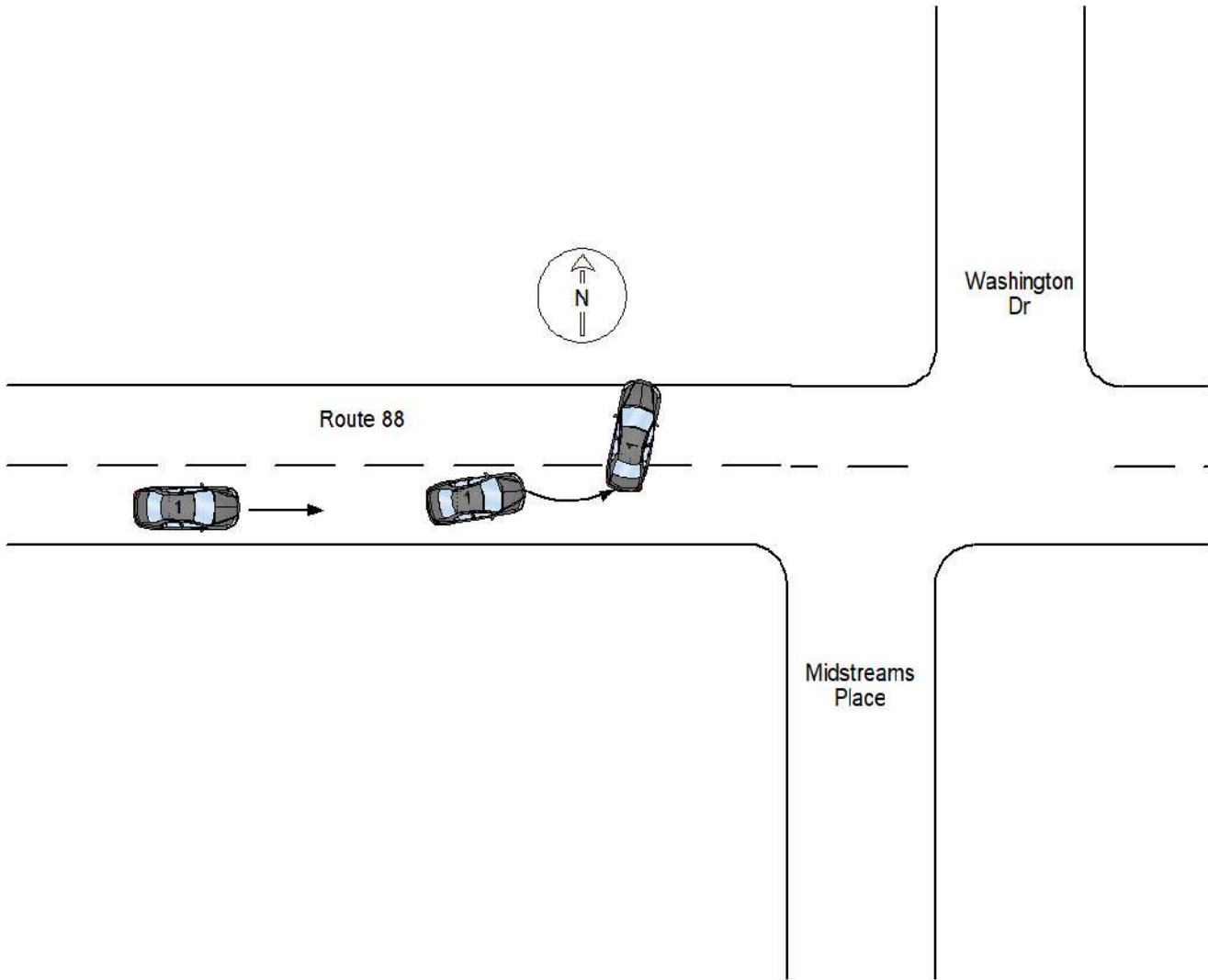
