145. Crash Description/Narrative

Vehicle #1 was pulling into a parking space in front of the Jersey Mike's Sub Shop (2085 Rt 88). Vehicle #2 was parked in the space next to the one that Vehicle #1 was pulling into. Vehicle #1 crashed into the open driver's side door of Vehicle #2 as the owner was sitting inside.

The driver of Vehicle #1 stated that as she was pulling into the space, she saw that the driver of Vehicle #2 had just gotten into his vehicle and believed that he was closing his door. She added that she then turned her attention elsewhere as she continued to park and crashed into Vehicle #2's open driver's side door.

The owner of Vehicle #2, Michael Obrien, stated that he had just entered into the driver's seat of his vehicle when Vehicle #1 crashed into his open door.

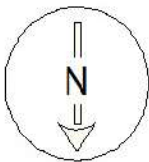
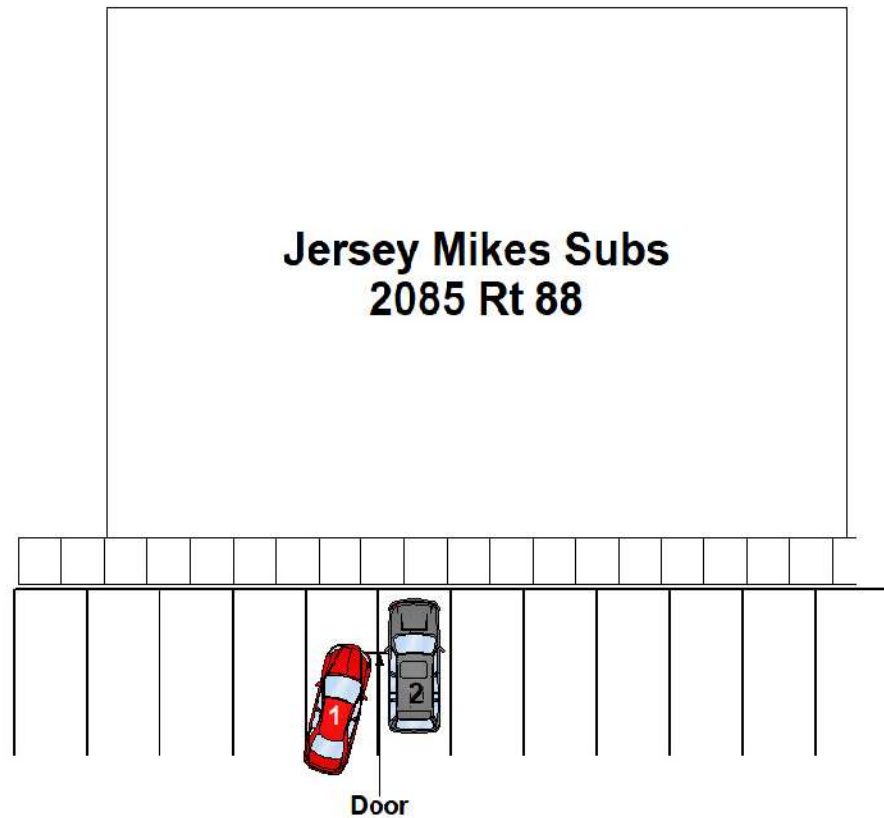
No injuries were reported on scene.
