145. Crash Description/Narrative

Vehicle 2 traveling in the right lane of Route 70 eastbound, entering the intersection of Route 70 and Route

88. Vehicle 1 traveling in the center lane of Route 70 eastbound, slightly behind and alongside Vehicle 2.

Driver 2 stated she was traveling through the intersection when she felt the impact of the collision and

looked in her outside rear view mirror. She saw Vehicle 1 completing a right hand turn onto Route 88 eastbound,

from the center lane where her vehicle was just struck. The metallic blue Dodge Durango did not stop and

continued eastbound on Route 88. Driver 2 pulled over and upon finding damage to the driver's side rear of her

vehicle, drove to the Brick Township Police Department to report the accident. The model of Vehicle 2 is EOS.

Driver 1 was found to be at fault for improper turning.

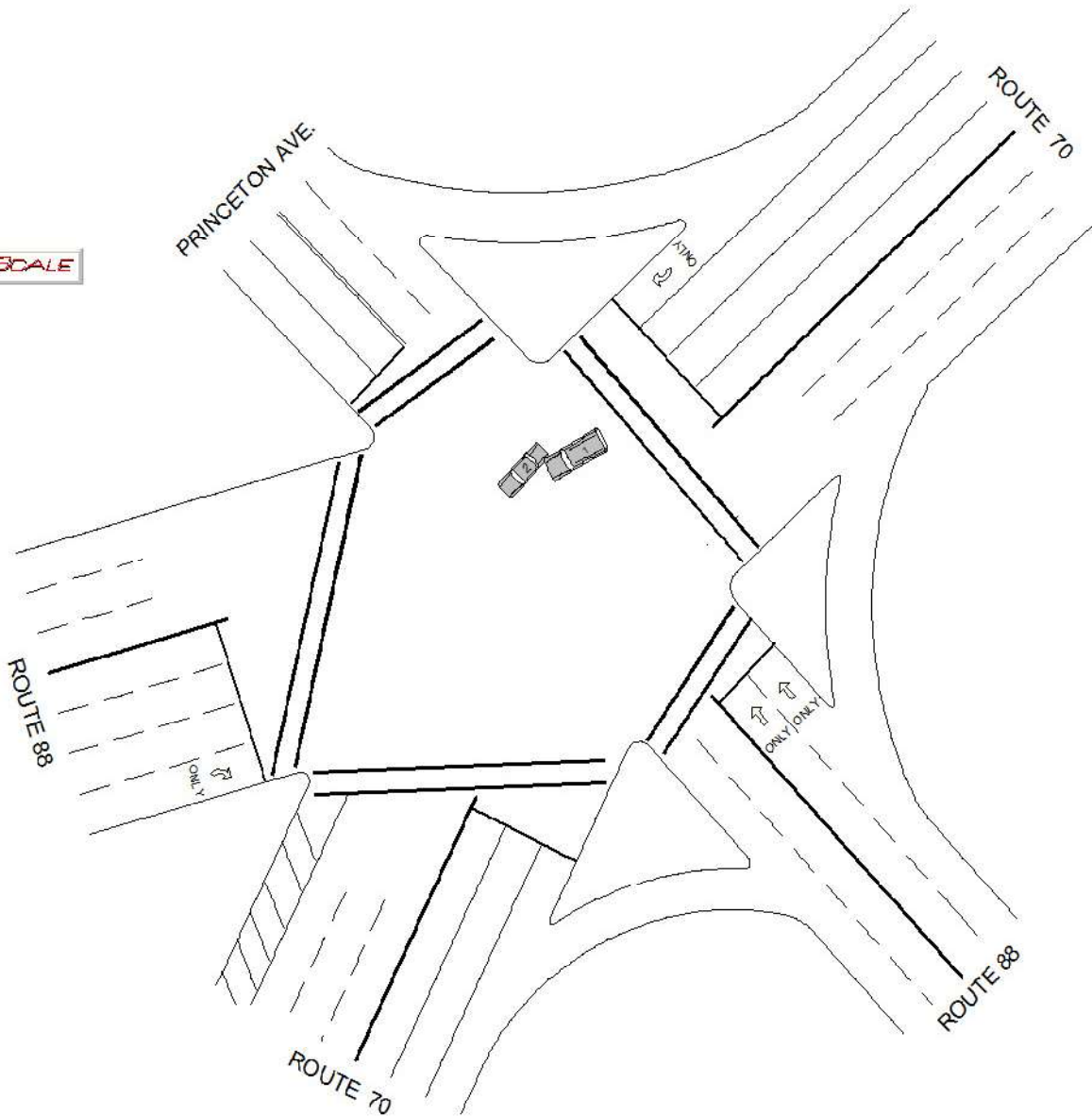
