145. Crash Description/Narrative

Vehicle #1 and Vehicle #2 were traveling eastbound on RT 88. Vehicle #1 and Vehicle #2 attempted to pass an unknown Vehicle on the right shoulder that was making a left turn in the RT 88 Walmart entrance (illegal left). As a result Vehicle #1 and Vehicle #2 collided in a same direction sideswipe. Vehicle #2 was directly behind the unknown Vehicle and Vehicle #1 was behind Vehicle #2.

Driver of Vehicle #1 stated he noticed an unknown vehicle in front of Vehicle #2 was making a left turn. Driver #1 stated Vehicle #2 remained behind the unknown vehicle so he attempted to pass both Vehicles on the right shoulder. Driver #1 stated without looking Vehicle #2 entered the shoulder and the two vehicles collided. As a result his Vehicle was pushed up and over the right side curb and off the road.

The driver of vehicle #2 stated the unknown Vehicle in front of him was making a left turn so he paused and then attempted to pass on the right shoulder. Driver #2 stated he did not observe Vehicle #1 prior to attempting to pass on the right.

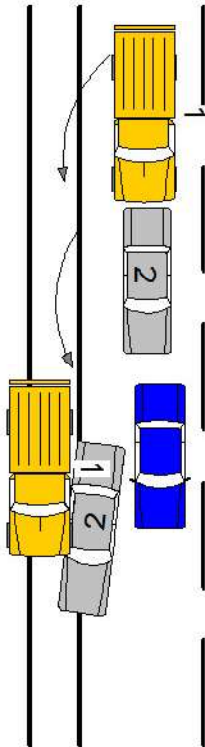

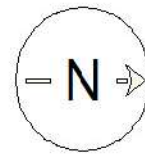
144 Crash Diagram (NOT TO SCALE)
