145. Crash Description/Narrative

V2 was traveling westbound on Rt. 88 approaching the area of 1608 Rt. 88. V1 was on the property of 1608 Rt. 88 attempting a left turn onto Rt. 88 eastbound.

D1 stated she attempted the turn onto the roadway and did not see V2. She was unable to bring her vehicle to a stop before striking V2. D2 stated he was going straight ahead on Rt. 88 and V1 pulled into the roadway striking the right side of his vehicle.

Both vehicles were moved prior to my arrival.

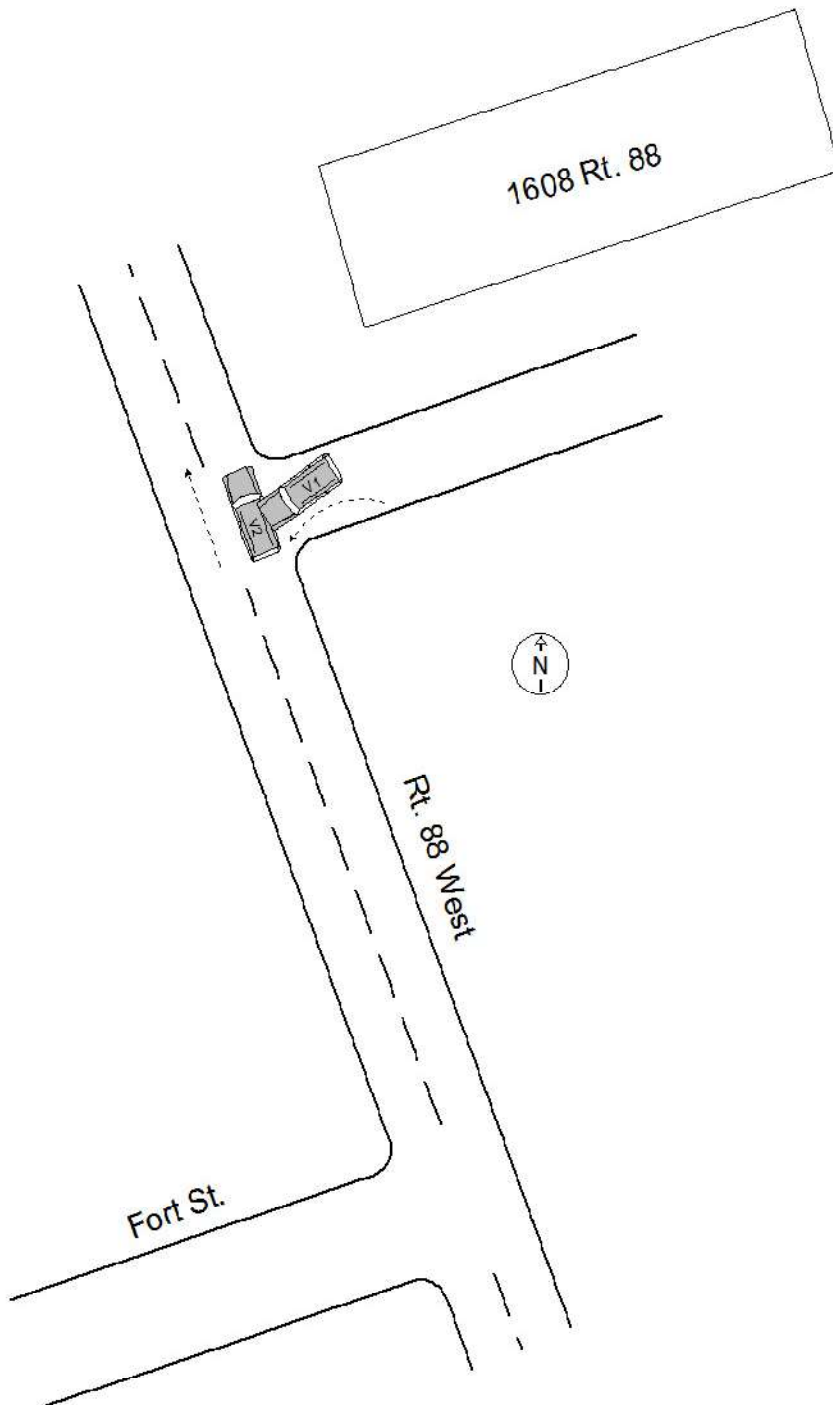
