145. Crash Description/Narrative

Vehicle 2 backing northbound out of a parking space, parking lot of Walmart, 1872 Route 88. Vehicle 1

backing southbound out of a parking space, directly behind Vehicle 2.

Driver1 stated he was backing southbound out of his parking space when he collided with Vehicle 2. He stated

he did not see Vehicle 2 until after the collision occurred.

Driver 2 stated she was backing northbound out of her parking space when she collided with Vehicle 1. She

stated she did not see Vehicle 1 until after the collision.

The accident occurred near the middle of the travel aisle. Both drivers stated they were backing when the

accident occurred and did not see the other vehicle. Fault was not able to be determined.

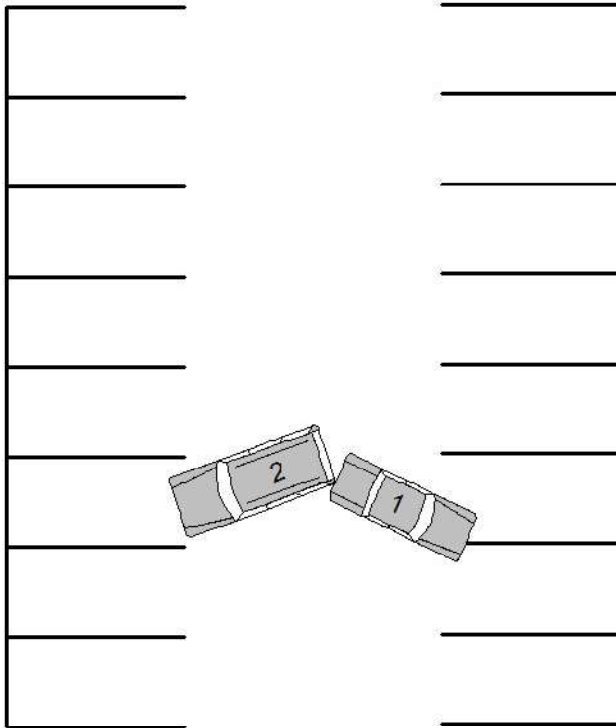
