145. Crash Description/Narrative

Investigation at the scene indicated the following: The rear of vehicle 2 was struck by the front of vehicle 1 while they were on Jack Martin Boulevard near the intersection with Route 88.

Driver 1 stated the following:

He was unable to stop his vehicle because the brakes failed. The front of his vehicle struck the rear of vehicle in front of him.

Driver 2 stated the following:

The rear of his vehicle was struck by another vehicle as he began to move forward in traffic.

It was determined on scene that driver 1 was at fault for the accident. When advising driver 1 that I would have to get his vehicle towed due to the unsafe brakes, he quickly changed his story and stated the brakes were okay. Once cleared from the accident, he was seen driving away in the vehicle and the brakes appeared to work properly.

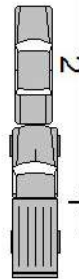
