145. Crash Description/Narrative

Vehicle #1 was traveling West on the Route 70 ramp in the area of Route 88. Vehicle #2 was traveling in front of Vehicle #1. As Vehicle #2 was yielding to traffic, Vehicle #2 failed to come to stop and struck Vehicle #2.

Driver #2 stated that she slowed down to yield to incoming traffic when Vehicle #1 crashed into the rear of her vehicle.

Driver #1 stated that he was behind of the Vehicle #2 when it began to slow down. At that time his foot slipped, because of the carpet mat, and he was not able to apply brakes. He crashed Vehicle #1 into Vehicle #2.

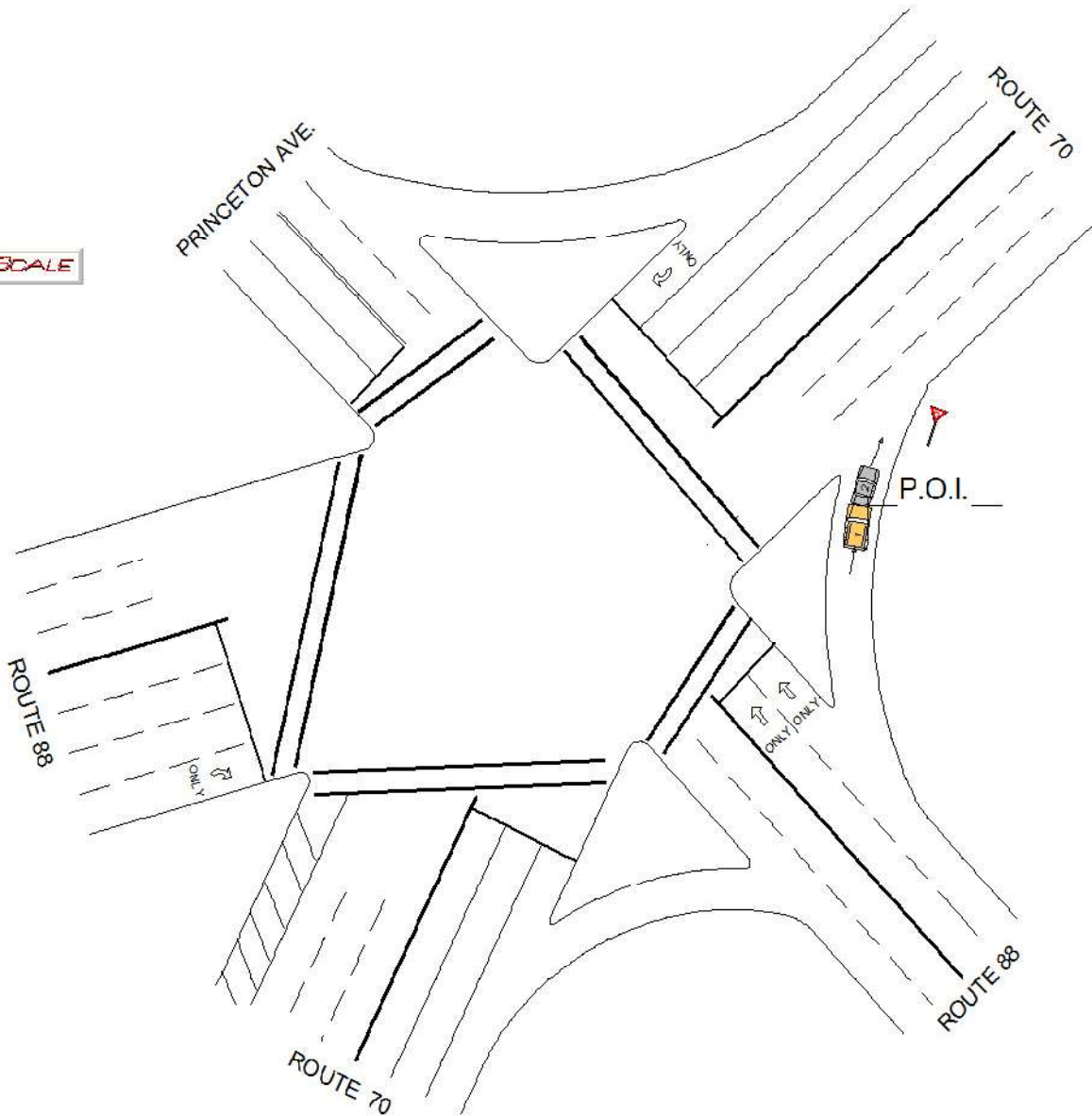
