145. Crash Description/Narrative

Investigation at the scene indicated the following: Vehicle 1 traveled eastbound on Route 88 behind vehicle 2.

Vehicle 2 traveled eastbound on Route 88 in front of vehicle 1. Vehicle 2 had slowed down in traffic to make a left turn. Vehicle 1 did not stop in time and hit vehicle 2 in the rear. Both vehicles were towed from the scene. Brick EMS arrived on scene to asses the passengers of vehicle 2, the passengers refused any further medical assistance.

I spoke to driver 1 at the scene. He stated he was driving eastbound and looked down for a brief moment. He looked up and noticed the vehicle was turning. He hit his brakes but could not stop in time. He believed driver 2 put on his directional to late and caused the accident.

I spoke to driver 2 at the scene. He stated he traveled eastbound and was making a left turn when he was hit from behind.

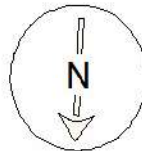
Based on statements made and damage to both vehicles, it was determined driver 1 was at fault. Driver 1 was issued a summons (2019-E19-006821) for Careless Driving (39:4-97).

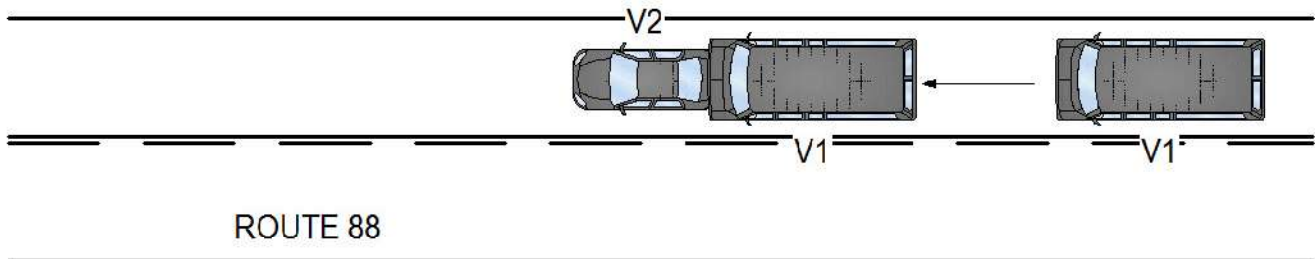
