145. Crash Description/Narrative

Investigation at the scene indicated the following: Vehicle 1 traveled on Route 88 westbound in the right lane.

Vehicle 2 traveled on Route 88 westbound in the right lane in front of vehicle 1. Vehicle 2 stopped at the traffic signal located at Route 88 and Post Road. Vehicle 1 thought vehicle 2 was going to continue through the traffic signal. Vehicle 1 did not stop in time and hit vehicle 2. Both vehicles sustained moderate damage.

I spoke to the driver 1 at the scene. She stated the light was yellow and thought the vehicle in front of her was going through the light and she hit the vehicle in front of her.

I spoke to driver 2 at the scene. She stated that she stopped for the traffic light and was hit from behind.

Driver 2 was transported to Ocean Medical Center for a complaint of pain.

Based on statements made and damage to the vehicles. It was determined Driver 1 was at fault

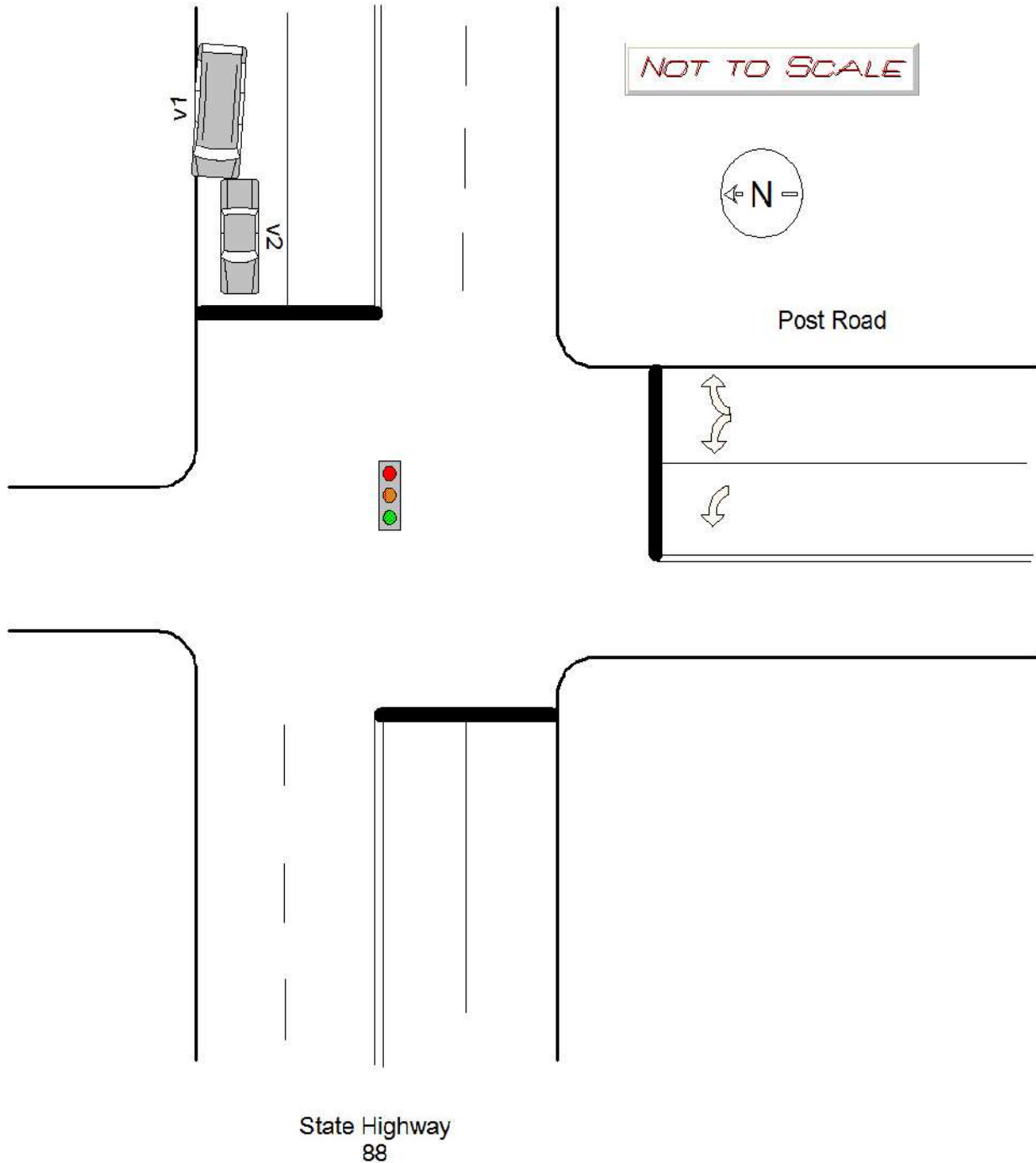
