145. Crash Description/Narrative

Vehicle 2 was stopped in traffic, Cedar Bridge Avenue westbound, in the right lane. Vehicle 1 was traveling behind Vehicle 2. Vehicle 1 failed to stop and struck Vehicle 2, causing damage. No injuries were reported on location. Vehicles were moved off the roadway and into the parking lot of Town Hall Shops prior to Police arrival.

Driver 1 advised that prior to the crash, he was stopped on Cedar Bridge Avenue, behind Vehicle 2. He stated that he observed Vehicle 2 start forward, so he accelerated forward. Driver 1 stated that his attention was diverted to his front seat passenger, and at that point, Vehicle 2 had come to a stop. Driver 1 stated that he was unable to stop and struck Vehicle 2 in the rear.

Driver 2 stated that prior to the crash, he was stopped on Cedar Bridge Avenue, in the right lane. He stated that the traffic signal for Jackson Avenue turned green and traffic on Cedar Bridge began to flow. Driver 2 stated that he then had to stop for traffic that stopped in front of his vehicle. Driver 2 stated that is when he was struck by Vehicle 1.

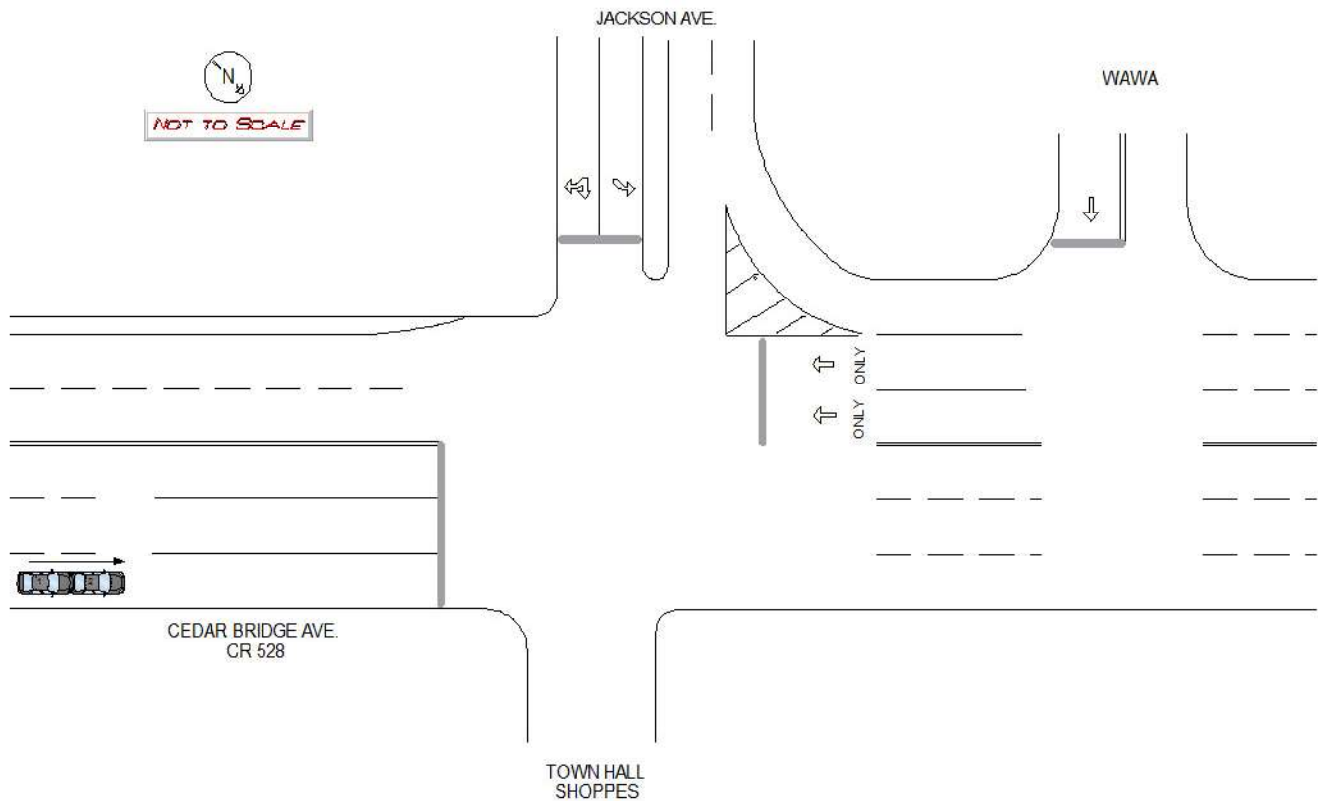
Motor Vehicle Crash Diagram
