145. Crash Description/Narrative

Vehicle #1 was traveling northbound on Jack Martin Blvd towards RT 88. Vehicle #2 was traveling southbound on Jack Martin Blvd towards RT 70. Vehicle #1 drifted over the center line into oncoming traffic. Vehicle #1 struck Vehicle #2 head on in the southbound lane.

Driver of Vehicle #1 stated he made a right turn from RT 70 onto Jack Martin and that was the last thing he could remember.

Driver of Vehicle #2 stated she was driving behind an SUV it swerved around and out of the way of Vehicle #1. She did not have time to move and was struck by Vehicle #1 in her lane.

A witness to the crash advised she saw Vehicle #1 drift into her lane and she swerved to avoid it. After avoiding it she looked into her rear view mirror and observed Vehicle #1 strike Vehicle #2 head on in the southbound lane.

The driver of Vehicle #1 was unconscious prior to police arrival. (Witness completed a Witness crash statement form).

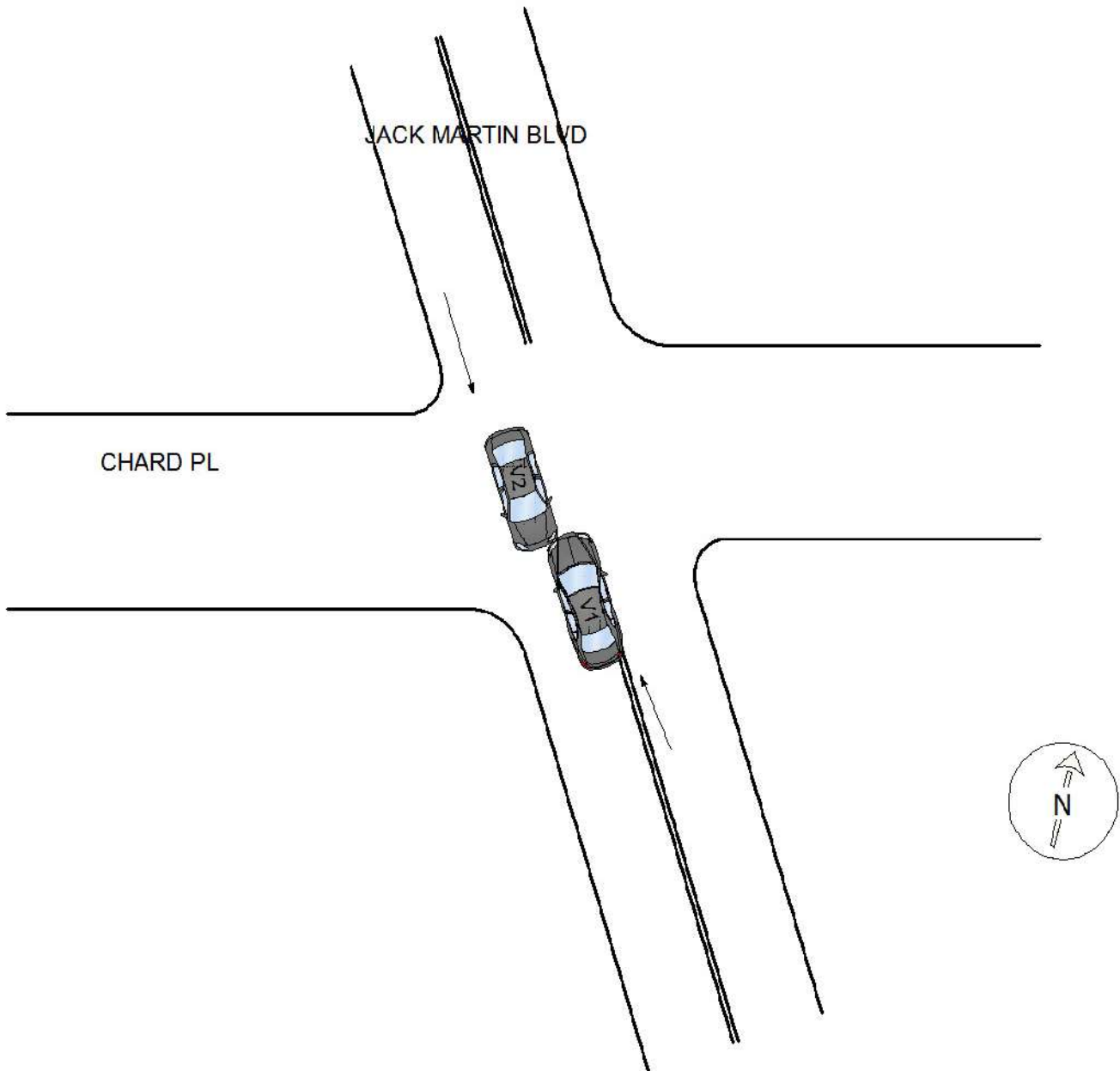
