145. Crash Description/Narrative

Vehicle #2 State Highway 70, stopped in traffic, was struck by vehicle #1. Vehicle #1 directly behind vehicle #2, going straight ahead, collided with vehicle #2. Driver #1 and Driver #2 stated that they were not injured.

Driver #1 stated that she observed the traffic signal turn green, she took her foot off the brake, was distracted by an object in her center console, removed her eyes from the road to look at object and when she looked up she observed vehicle #2 and struck it. Driver #2 stated that she was stopped in traffic and was struck by vehicle #1.

I observed minor damage to the front passenger side of vehicle #1 and I observed minor damage to the rear passenger side of vehicle #2. Driver #1 failed to observe vehicle #2 stopped in roadway and collided with it.

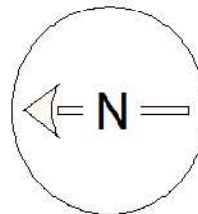
