145. Crash Description/Narrative

My investigation revealed the following:

Vehicle 1 was traveling south on Jack Martin Blvd. in the left lane approaching the intersection with Burrsville Rd. Vehicle 2 was traveling south on Jack Martin Blvd. directly next to vehicle 1. Vehicle 1 attempted to make a right turn from the left lane onto Burrsville Rd. and struck the passenger side of vehicle 2.

Driver 1 stated she was traveling south on Jack Martin Blvd. approaching the intersection with Burrsville Rd. and attempting to make a right turn onto Burrsville Rd. As she was making the turn she struck the side of vehicle 1. She stated vehicle 1 came out of nowhere and did not see it prior to the crash. Driver 1 stated she did not know what lane she was in and did not realize there were two lanes.

Driver 2 stated she was traveling south on Jack Martin Blvd. in the right lane. As she was approaching the intersection with Burrsville Rd. she was struck in the side without warning.

Based upon the above circumstances I find driver 1 to be at fault for the crash.

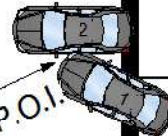
