145. Crash Description/Narrative

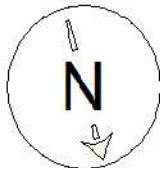

144 Crash Diagram (NOT TO SCALE)

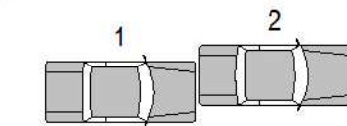
