145. Crash Description/Narrative

Crash Investigation Reveals: Vehicle #2 was traveling south on Vanzile Road. Vehicle #1 was stopped at a stop sign in the parking lot of 191 Van Zile Road. As Vehicle #1 attempted to make a left turn out of the parking lot, the front bumper of his vehicle came into contact with the rear passenger side door of vehicle #2.

Driver #2 stated while traveling south on Van Zile Road, she observed vehicle #1 stopped at the stop sign. As she passed vehicle #1, it started into the intersection and made contact with her vehicle.

Driver #1 stated he stopped for the stop sign then attempted to make a left turn. While making the left turn his front bumper came into contact with vehicle #2's rear passenger side door. Driver #1 stated he did not see vehicle #2 as he pulled out.

Through observations and statements observed while on scene, I find driver #1 at fault for failing to yield to right away. No injuries reported. Both vehicles suffered minor damage and were driven off scene by owners.

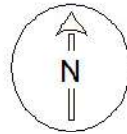

144 Crash Diagram (NOT TO SCALE)

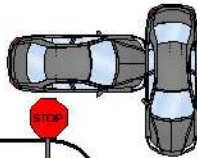
