145. Crash Description/Narrative

Vehicle#3 was traveling East on Route 70 in the ramp lane from Route 70 East to Van Zile Rd. North. Vehicle#2 was traveling directly behind Vehicle#3. Vehicle#1 was traveling directly behind Vehicle#2. Vehicle's#2 and #3 came to stop at which time Vehicle#1 struck Vehicle #2. Vehicle#2 was then set in motion and struck Vehicle#3.

Driver#3 stated he came to a stop due to traffic. Driver#2 stated he came to a stop because of Vehicle#3, he was then struck by Vehicle#1 which caused his vehicle to be set in motion and strike Vehicle#3. Driver#1 stated that Vehicle#2 came to an abrupt stop causing her to strike Vehicle#2. Driver#1 was determined to be at fault.

Driver#1 complained of finger pain but refused first aid. All other drivers and occupants refused first aid.

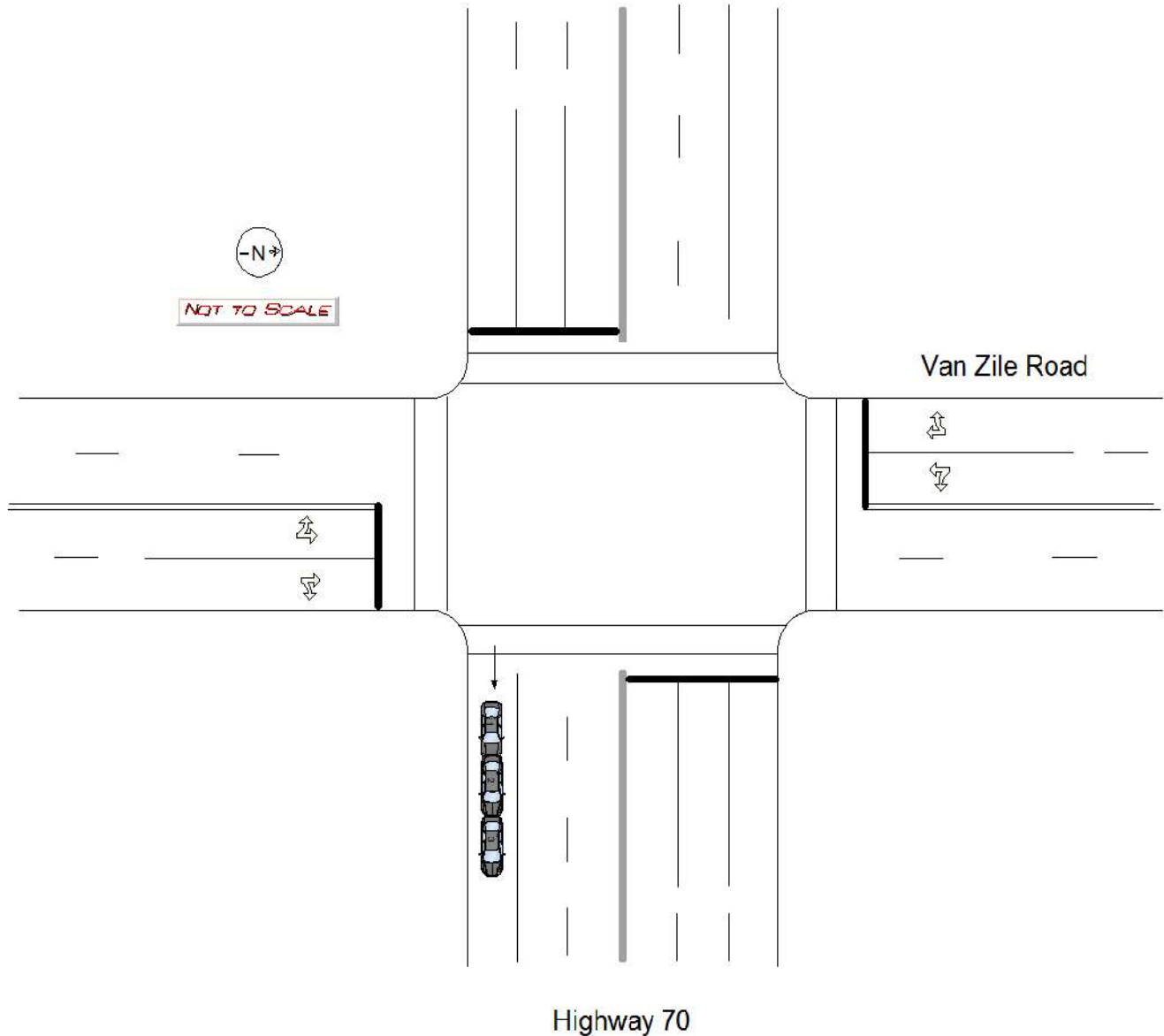
