145. Crash Description/Narrative

Vehicle #2 was stopped at the traffic signal in the far right lane of Route 70 West Bound. Vehicle #1 was stopped directly behind Vehicle #2. Vehicle #1's front bumper hit Vehicle #2's rear bumper.

Driver of Vehicle #2 stated she was stopped at the traffic signal in the far right lane of Route 70 West Bound. At that time Vehicle #1's front bumper hit her rear bumper.

Driver of Vehicle #1 stated she was stopped directly behind Vehicle #2. She saw Vehicle #2 let off her brakes and travel forward. She did not realize Vehicle #2 was going to come to a stop and could not stop in time. At that time her front bumper hit Vehicle #2's rear bumper.

Based off my observations and both driver's statements I find Vehicle #1 at fault for following too closely. No injuries were reported at the time of the crash.

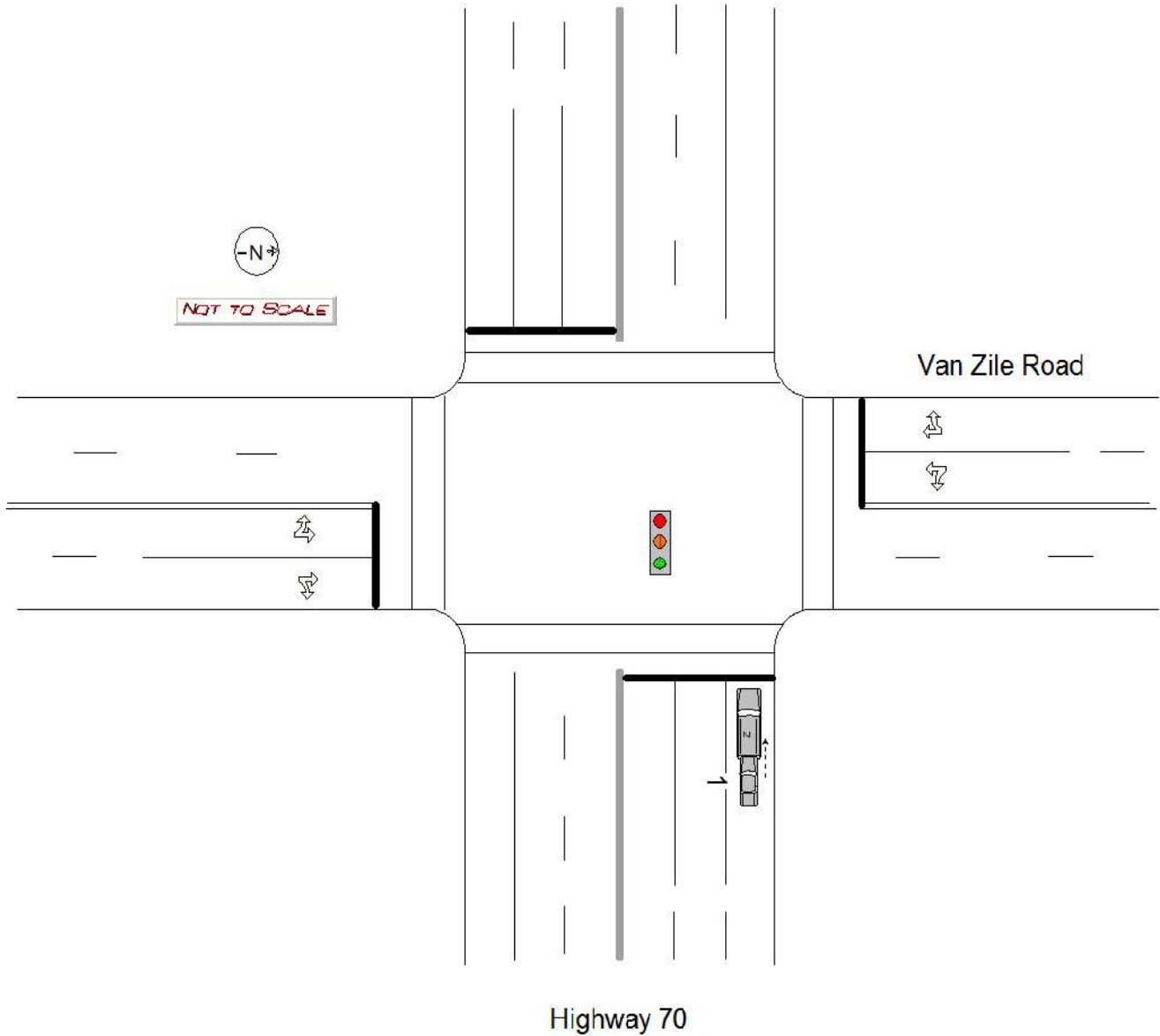
