145. Crash Description/Narrative

Investigation revealed that vehicle #1 was attempting to make a legal U-turn onto Burrsville Road North from Burrsville Road South when he made contact with the wooded telephone style pole curbing(1563 Burrsville Road) with it's passenger side front lower bumper. The curbing is approximately one and a half feet high and not common style curbing for the edge of a yard. The curb did not have any visible damage.

Driver of vehicle #1 stated he was attempting to make a U-turn onto Burrsville North from Burrsville Road south, when he "Tapped" the wooden curbing in front of house #1563 Burrsville Rd. causing damage to his vehicle. Driver of vehicle #1 said there were two vehicle's in front of him stopped for the red traffic signal which also caused him to miss judge the distance. Driver of vehicle #1 stated he did not see the un-usual style curbing due to it's height.

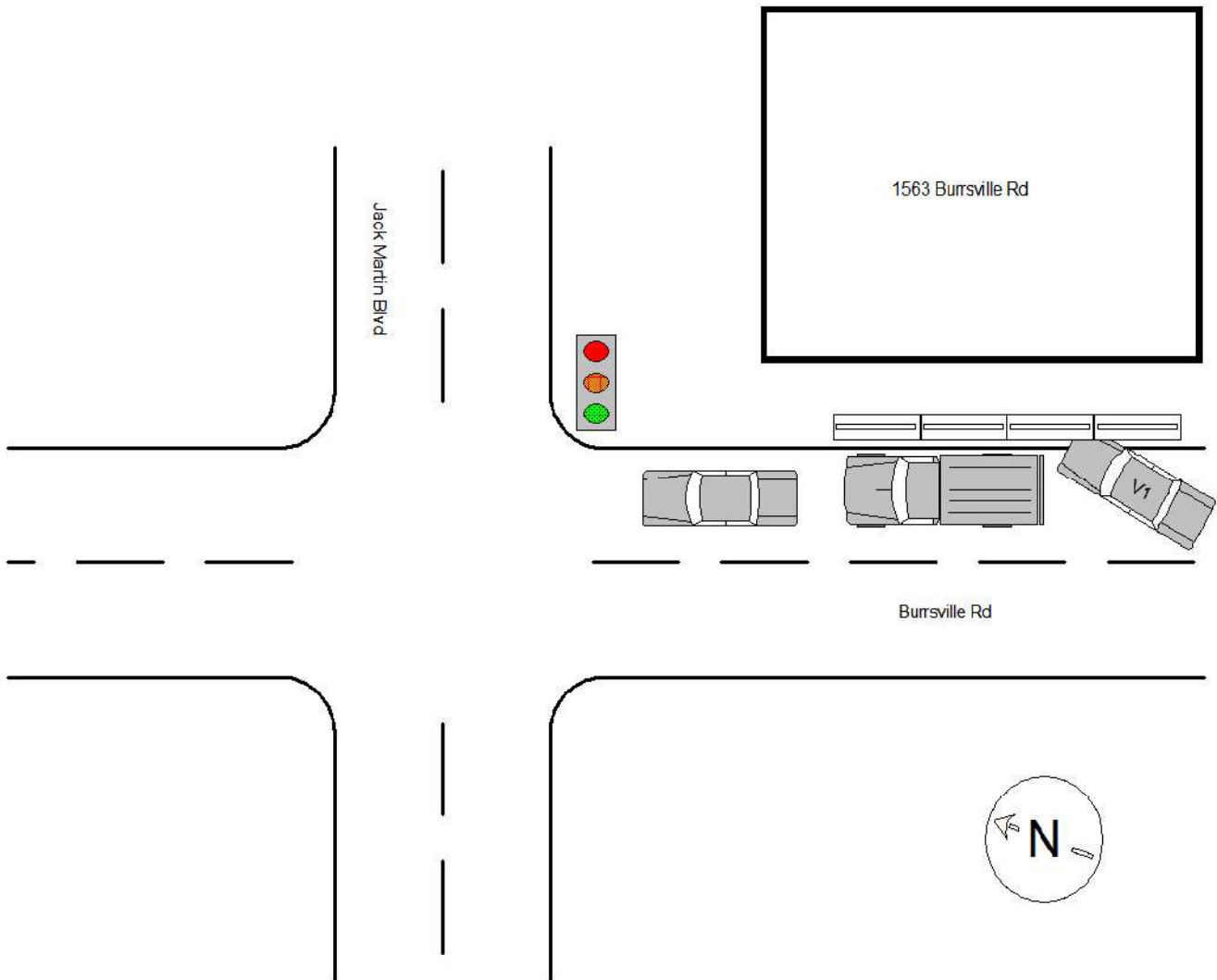
