145. Crash Description/Narrative

Vehicle #1 was traveling westbound on RT 70 in the left lane directly behind Vehicle #2. Vehicle #1 collided with Vehicle #2 in a rear end crash.

Driver #1 stated she was traveling directly behind Vehicle #2 when Vehicle #2 stopped for traffic. Driver #1 stated she initiated her brakes but was unable to stop in time to avoid the crash. Driver #1 advised she believed the rain caused her Vehicle to hydroplane into vehicle #2.

Driver #2 advised she was in the left lane traveling westbound on RT 70 and came to a stop for traffic. Driver #2 stated as his vehicle stopped it was struck from behind by vehicle #1.

Based on my observations and statements made by both parties I found the driver of Vehicle #1 at fault for the crash for following to closely.

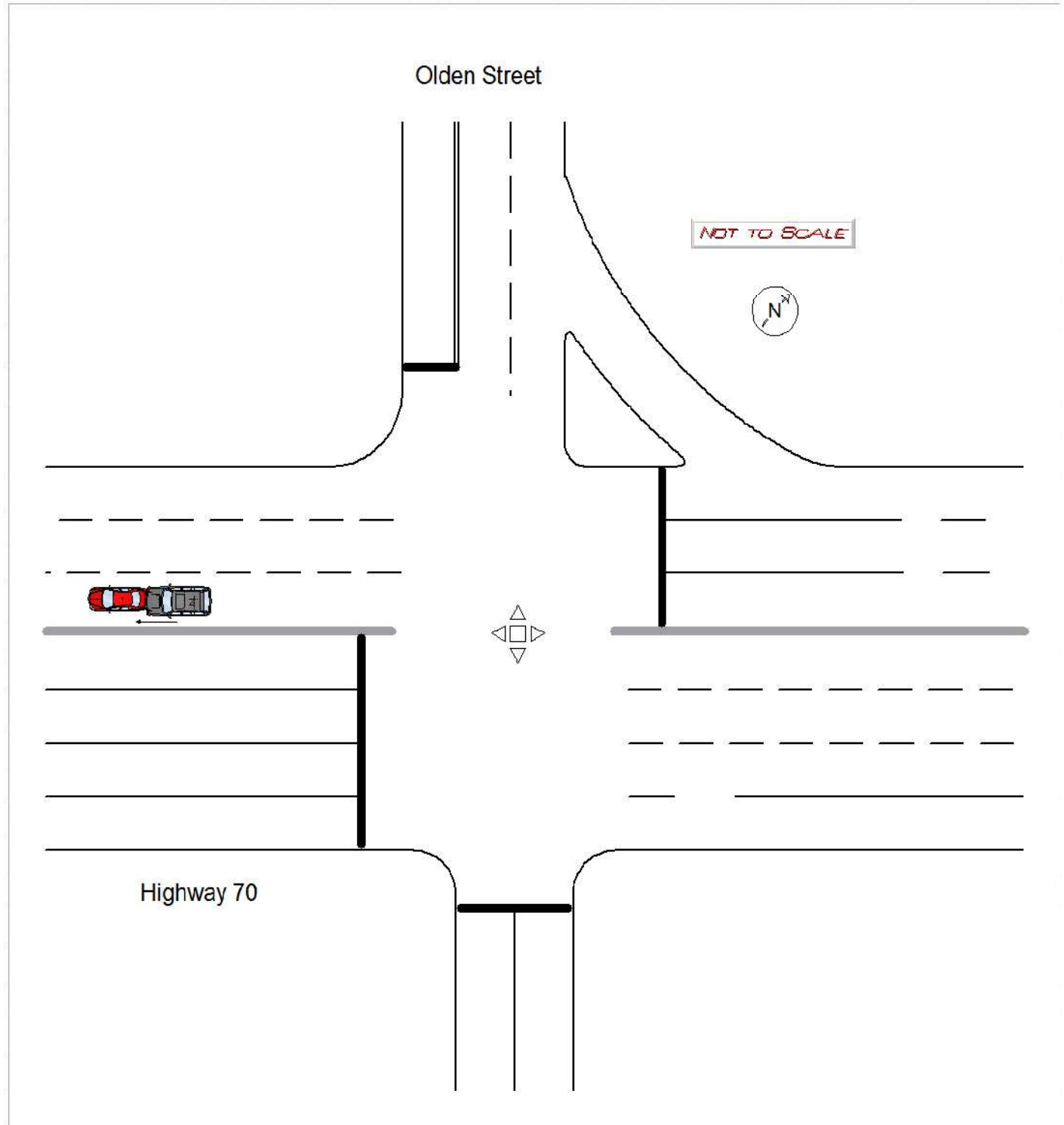
