145. Crash Description/Narrative

Vehicle 1 backing southbound out of a parking space, parking lot of Walmart, 1872 Route 88. Vehicle 2

backing northbound out of a parking space, parking lot of Walmart, 1872 Route 88.

Driver 1 stated she was backing southbound out her parking space and did not see any vehicles in her backup camera. As she was backing, she felt the impact of her vehicle striking the rear of Vehicle 2.

Driver 2 stated as she started to back northbound out of her parking space, she observed Vehicle 1 backing also. Driver 2 stated she stopped and then Vehicle 1 stopped. Believing Vehicle 1 was allowing her to go.

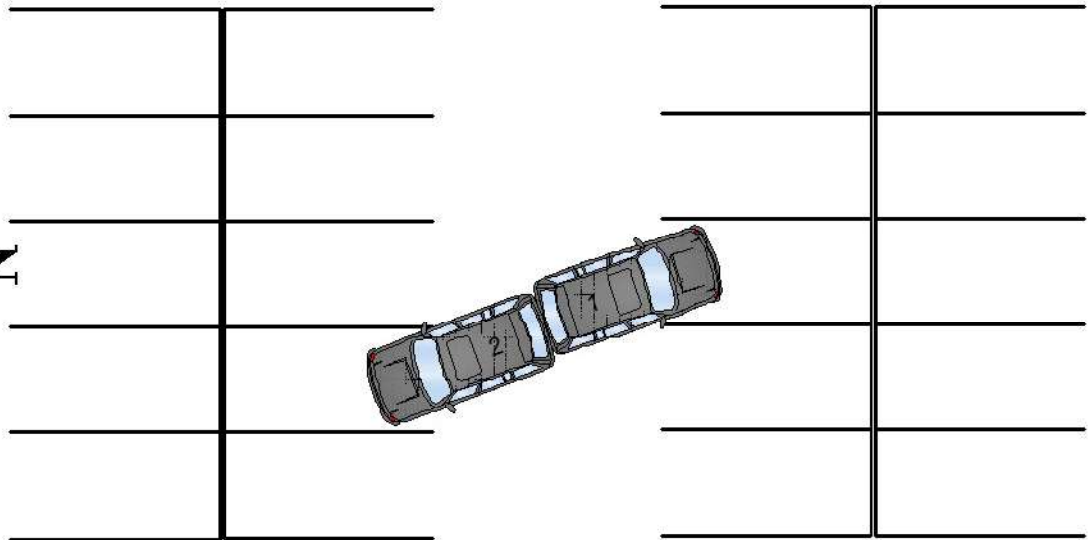
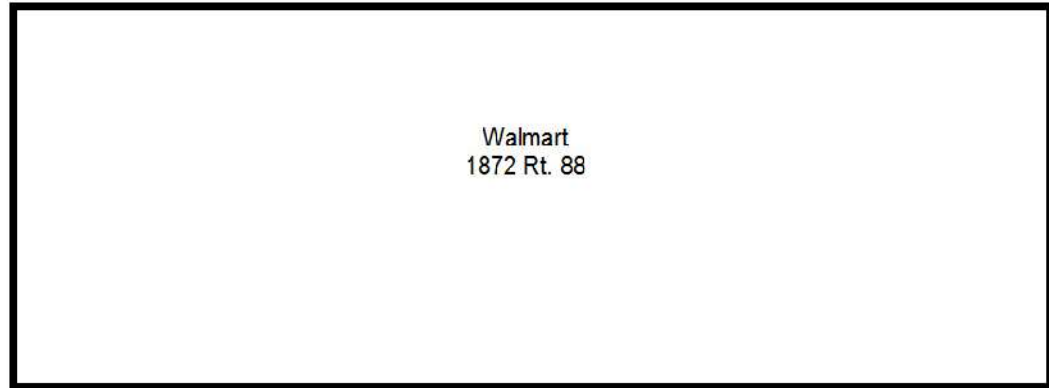
Driver 2 began backing again and did not see Vehicle 1 begin to start backing also. Driver 2 then felt the impact of her vehicle striking Vehicle 1.
