145. Crash Description/Narrative

Two vehicle crash occurred on 10/9/2019 at approximately 0838 hours eastbound on Route 88. My body worn camera was on during this investigation.

Driver of vehicle #1, Bradley Schlatter, advised he was approaching the intersection of Route 88 and Jack Martin Blvd. and observed a red light. Schlatter stated he depressed his brakes and his brakes locked up and the vehicle skid. Schlatter advised he struck vehicle #2 in the rear with the front of his vehicle.

Driver of vehicle #2, Mineshkum Patel, advised he was stopped at a red light at the intersection of Jack Martin Blvd and Route 88 and was struck from behind by vehicle #1. Patel stated he was not the first car at the light and was waiting behind several other vehicle.

No tows were required, no summons were issued, and no injuries were reported at the scene.

My investigation finds vehicle #1 at fault for unsafe speed.

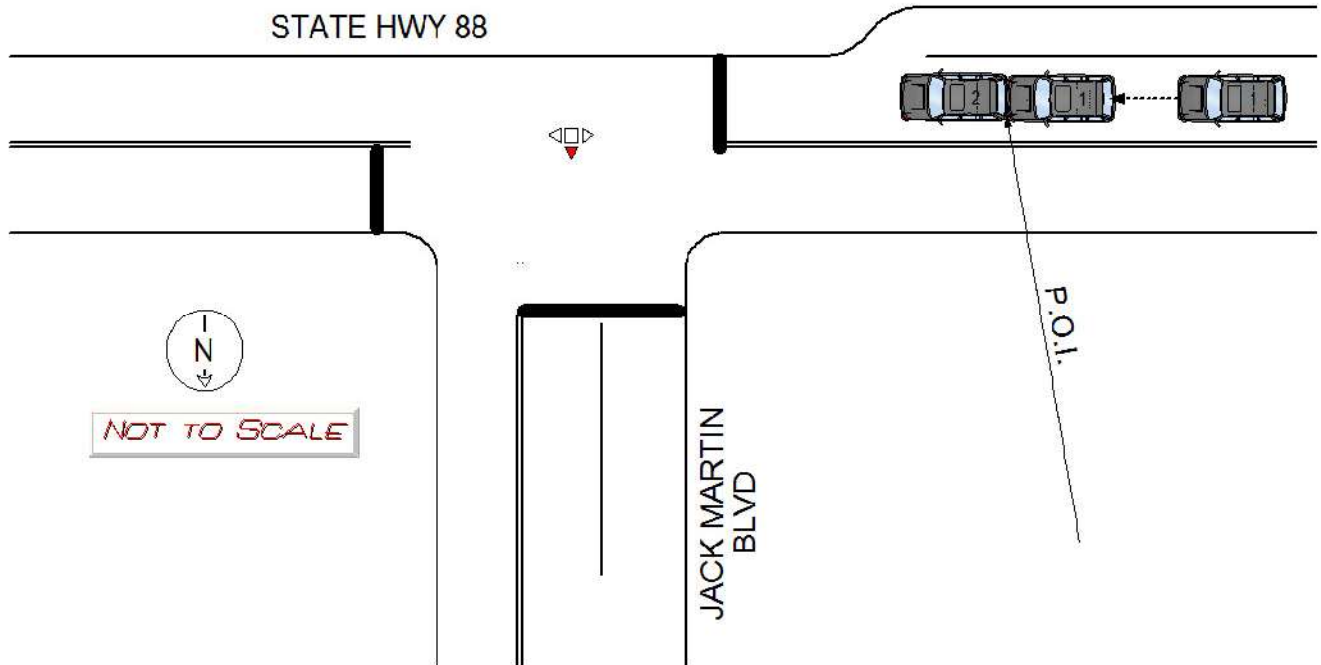
