145. Crash Description/Narrative

Vehicle #1 was traveling east on Rt 70 entering the intersection with Rt 88, behind Vehicle #2. When Vehicle #2 stopped abruptly for another vehicle that also stopped short, Vehicle #1 crashed into the rear of Vehicle #2.

The driver of Vehicle #1 stated that the vehicle in front of Vehicle #2 stopped short in traffic and attempted to make an illegal left turn onto Rt 88 west. He explained that when Vehicle #2 stopped quickly for the other vehicle, he attempted to do the same but was unable to in time, crashing into Vehicle #2's rear bumper.

The driver of Vehicle #2 stated that the vehicle in front him had stopped short and tried to make an illegal left turn (despite the no turns signs). He added that he had to stop quickly to avoid crashing into that vehicle. He explained that when he stopped, Vehicle #2 did not stop in time and crashed into his rear bumper.

No injuries were reported on scene.

Ptl Valeri #244 and I spoke to the other driver, 89 year old Isabelle Kozak, who had stopped after the crash. Kozak stated that she stopped to make the left turn from Rt 70 east bound onto Rt 88 west bound as she did not know it was illegal to do so. When she realized her mistake she started in traffic again on Rt 70 before hearing the crash and seeing the smoke behind her. She explained that she continued straight on Rt 70 and later stopped.

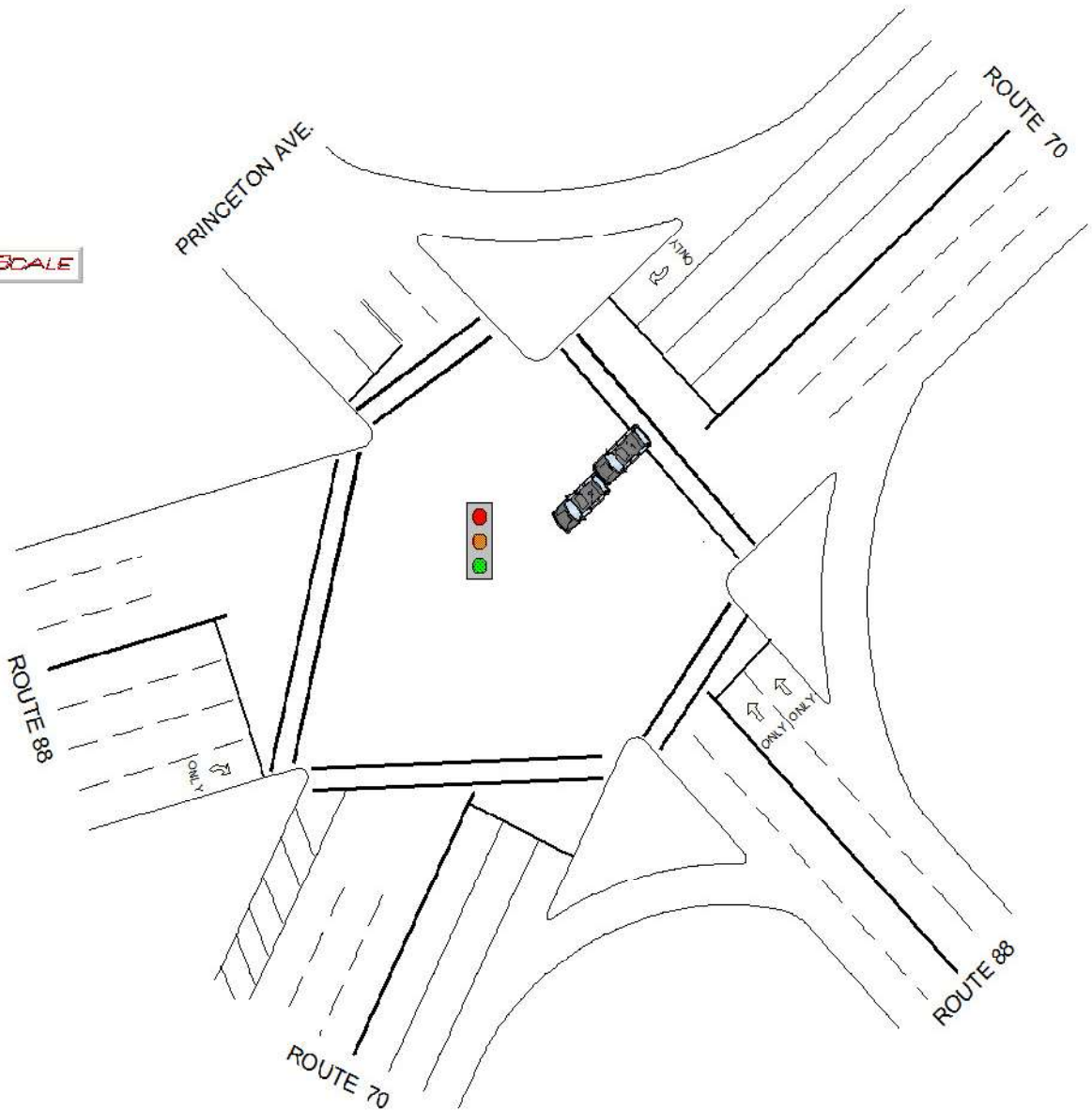
