145. Crash Description/Narrative

Vehicle 1 and 2 were both traveling eastbound on Rt 70. Vehicle 2 was in the middle lane and vehicle 1 was in the rightmost. Vehicle 1 then failed to maintain their lane causing a side swipe collision with vehicle 2.

The driver of vehicle 1 advised he was traveling eastbound on Rt 70 in the rightmost lane. Driver 1 further advised he was preparing to make a lane change when an unknown vehicle honked their horn. Driver 1 advised he must have drifted into vehicle 2's lane causing a collision.

The driver of vehicle 2 advised she traveling eastbound on Rt 70 in the middle lane. A vehicle in front of her began slowing and she slowed as well. Vehicle 1 then collided with her vehicle.

The driver of vehicle 1 is found to be at fault for the collision.

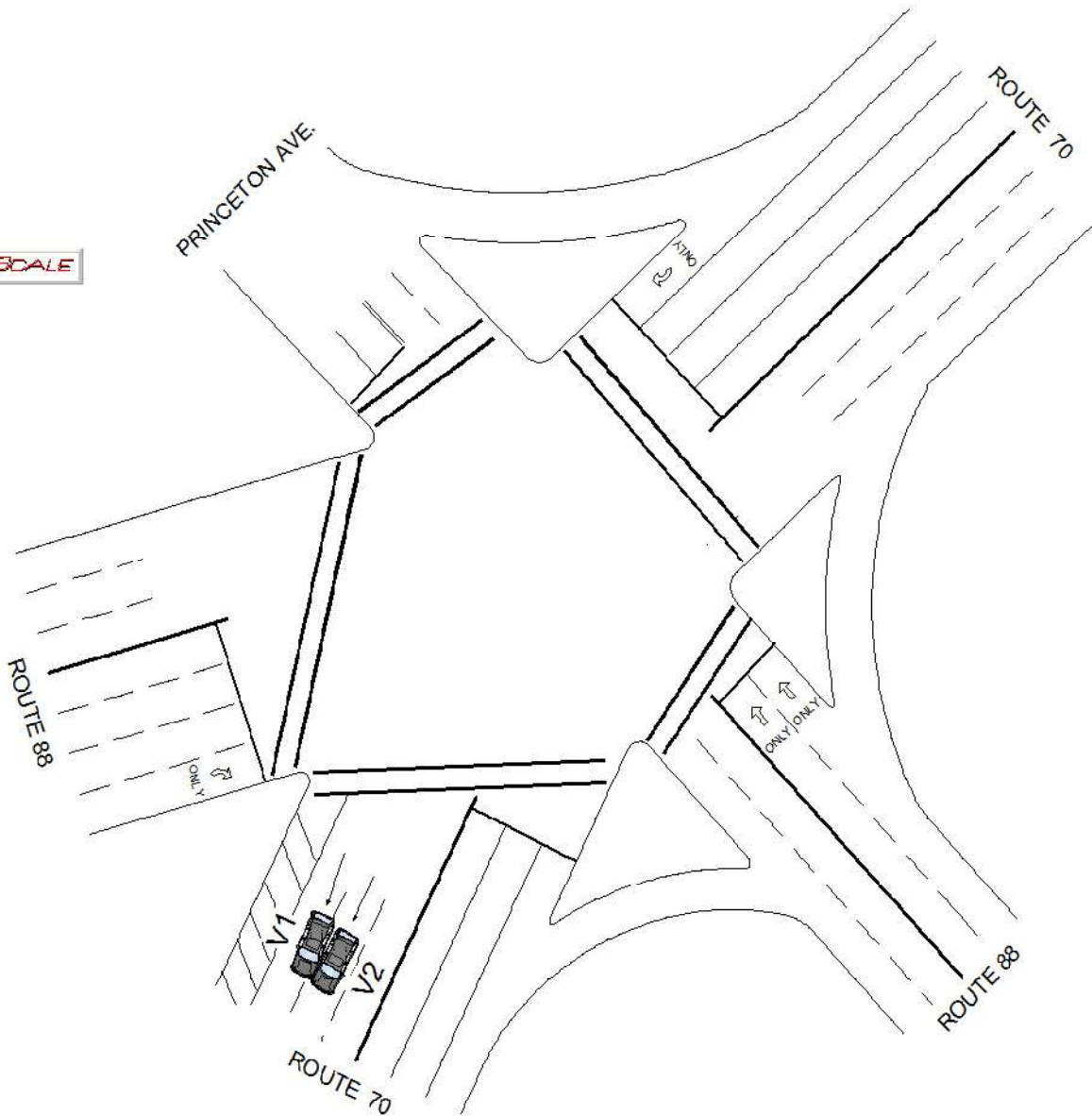
