145. Crash Description/Narrative

Upon arrival, Driver #1 stated she misjudged the left turn attempting to park and subsequently side swiped vehicle

#2 left rear bumper/fender with the front right bumper of vehicle #1. Vehicle #2 was legally parked within the

lane markings at the time of the accident.

Vehicle #1 had a dent on the right bumper that was determined to be there prior to this accident, and vehicle #2

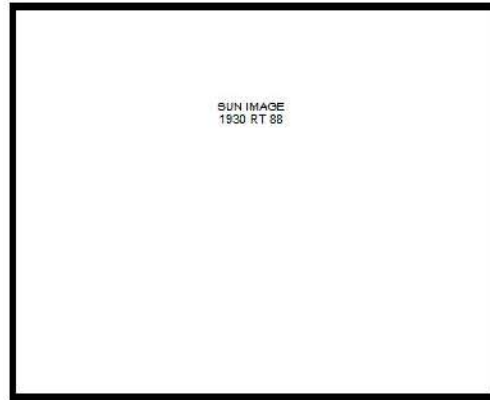
had minor blemishes/ paint markings on the left bumper/fender that appeared to be superficial.

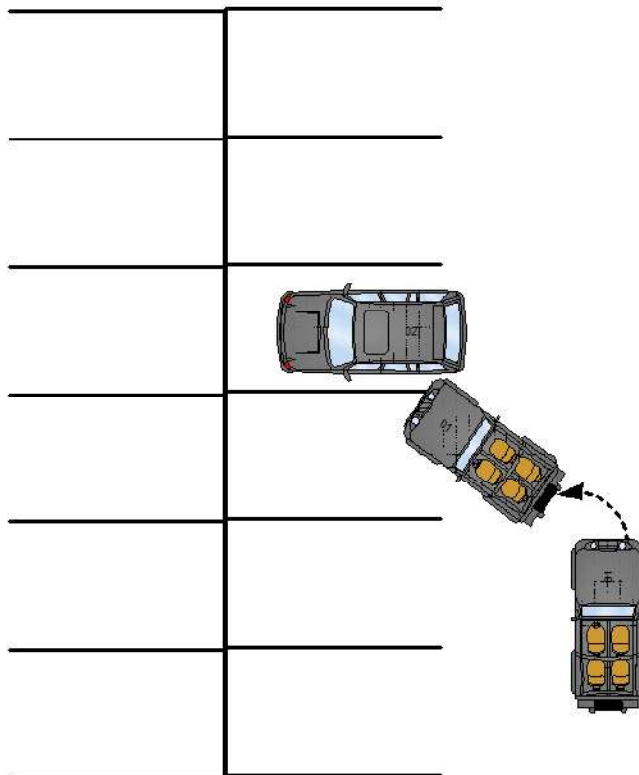
