145. Crash Description/Narrative

Investigation revealed that vehicle #1 was backing out of a parking space when it crashed into the left rear bumper of occupied/parked vehicle #2 with it's right rear bumper.

Driver of vehicle #1 stated she was backing out of the parking space and did not see vehicle #2 due to an ambulance which was parked near by. She said her concentration was not on hitting the ambulance and subsequently crashed into vehicle #2.

Driver of vehicle #2 stated she dropped off her husband at this address for an appointment and was about to leave when vehicle #1 crashed into her rear bumper.

All refused medical attention on scene.

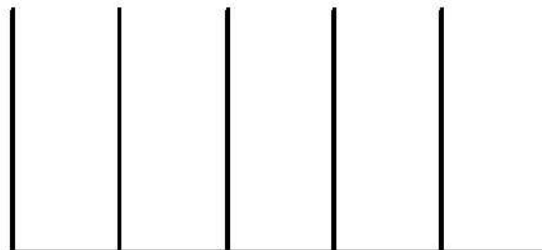
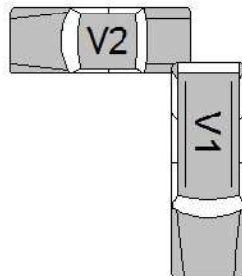
