145. Crash Description/Narrative

On scene investigation concluded: Vehicle #1 was traveling on Rt. 70 (Eastbound) when it failed to stop at the red traffic signal located at the intersection with Olden St. Vehicle #2 was starting in traffic after the green traffic signal from the jug handle off Rt. 70 onto Olden St. Vehicle #2 began to cross over Rt. 70 and was struck by Vehicle #1. Vehicle #1 is at fault.

Driver of Vehicle #1 advised she was on Rt. 70 attempting to take the jug handle onto Olden St. when she failed to observe the red traffic signal. Driver of Vehicle #1 relayed she entered the intersection and struck Vehicle #2 as it began to cross over Rt. 70. Driver of Vehicle #1 advised she was at fault.

Driver of Vehicle #2 advised she was stopped on the jug handle attempting to cross over Rt. 70 when she observed the green traffic signal. Driver of Vehicle #2 stated she started in traffic and was struck by Vehicle #1 as she entered the intersection.
