145. Crash Description/Narrative

Vehicle 2 traveling in the right lane of Route 70 eastbound, approaching Route 88. Vehicle 1 traveling in the center lane of Route 70 eastbound, approaching Route 88.

Driver 1 stated he never realized he was involved in an accident until the witness told him.

Driver 2 stated he was traveling in the right lane of Route 70 eastbound, intending on continuing straight through the intersection. Driver 2 stated as he was approaching the intersection, he felt the impact of Vehicle 1 striking his vehicle. Driver 2 then turned off onto Princeton Avenue to get off the roadway. Driver 2 stated he did not see where Vehicle 1 had driven off to.

The witness Joseph Morgan reported he captured the accident on his dash camera as well as watched the accident occur. Morgan stated he saw Vehicle 1 make a lane change to the right and strike Vehicle 2 on the driver's side with the passenger side of Vehicle 1. Morgan was able to playback the video for me, showing Vehicle 1 changing lanes and striking Vehicle 2.

Driver 1 was found to be at fault for an improper lane change.

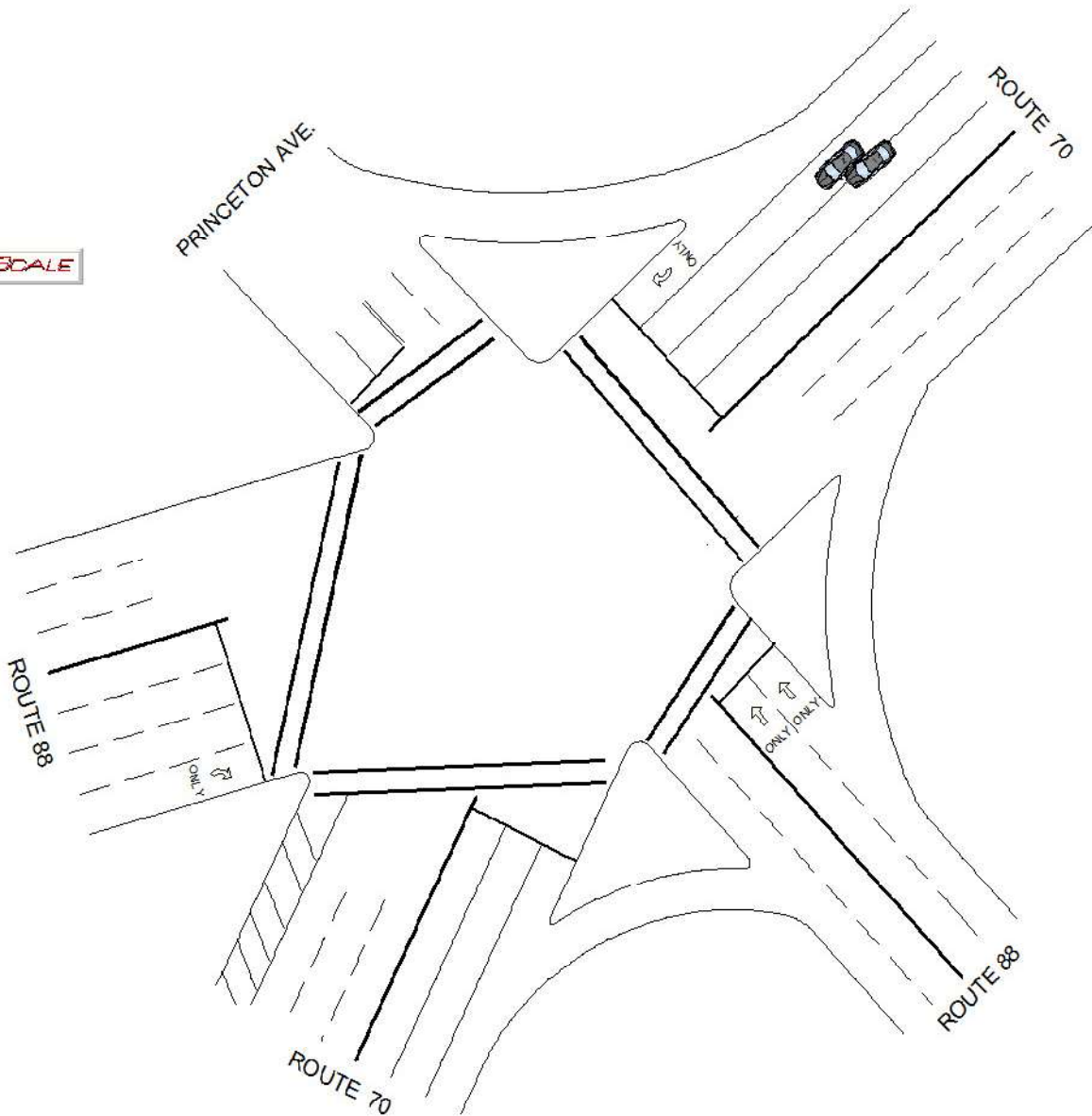
