145. Crash Description/Narrative

Crash investigation revealed an opposite direction, head-on, crash involving two vehicles.

Vehicle 1 was traveling east on Route 88 when the driver lost control of his vehicle and entered into the opposite lane of traffic. The front of Vehicle 1 then hit the front left side of Vehicle 2.

Vehicle 2 was traveling west on Route 88 when Vehicle 1 entered the westbound lane and struck the front left side of Vehicle 2. Vehicle 2 then ran off the road to the right, struck a curb and came to rest approximately 20 feet off the road.

Driver of Vehicle 1 stated that he had lost control of his vehicle while traveling east on Route 88 when he hit Vehicle 2. It was discovered that the driver of Vehicle 1 did not have a valid driver's license. The Driver of vehicle 1 was identified as Maynor Roberto Galdamez- Ramirez, using the passport that was provided (Honduras Passport # E218247)

Driver of Vehicle 2 stated that she was traveling west on Route 88 when Vehicle 1 entered her lane and struck the

front left side of her vehicle. She further stated that the initial crash caused her to steer right.

Upon observation of Vehicle 1, I observed disabling front end damage to the vehicle. Upon observation of Vehicle 2, I observed disabling front left side damage that extended to the left middle of the vehicle. I also observed airbag deployment on the left side of vehicle 2.

The Driver of vehicle 1 was driving with two other passengers in the vehicle, one of the passengers was the driver's infant daughter. The driver of Vehicle 1 stated that he and his infant daughter sustained no injuries and declined medical treatment. The other passenger of Vehicle 1 also stated that she sustained no injuries and declined medical treatment.

The Driver of Vehicle 2 was driving with one other passenger whom is the driver's 5 year old daughter. The Driver of vehicle 2 stated that she and her daughter sustained no injuries and both declined medical treatment.

There were also two individuals on scene that witnessed the crash, both individuals provided similar accounts on what had occurred. Both individuals were provided Witness Statement Forms, which were completed and submitted.

The driver of Vehicle 1 is covered by a Maryland based insurance company. There was no insurance code on the insurance card.

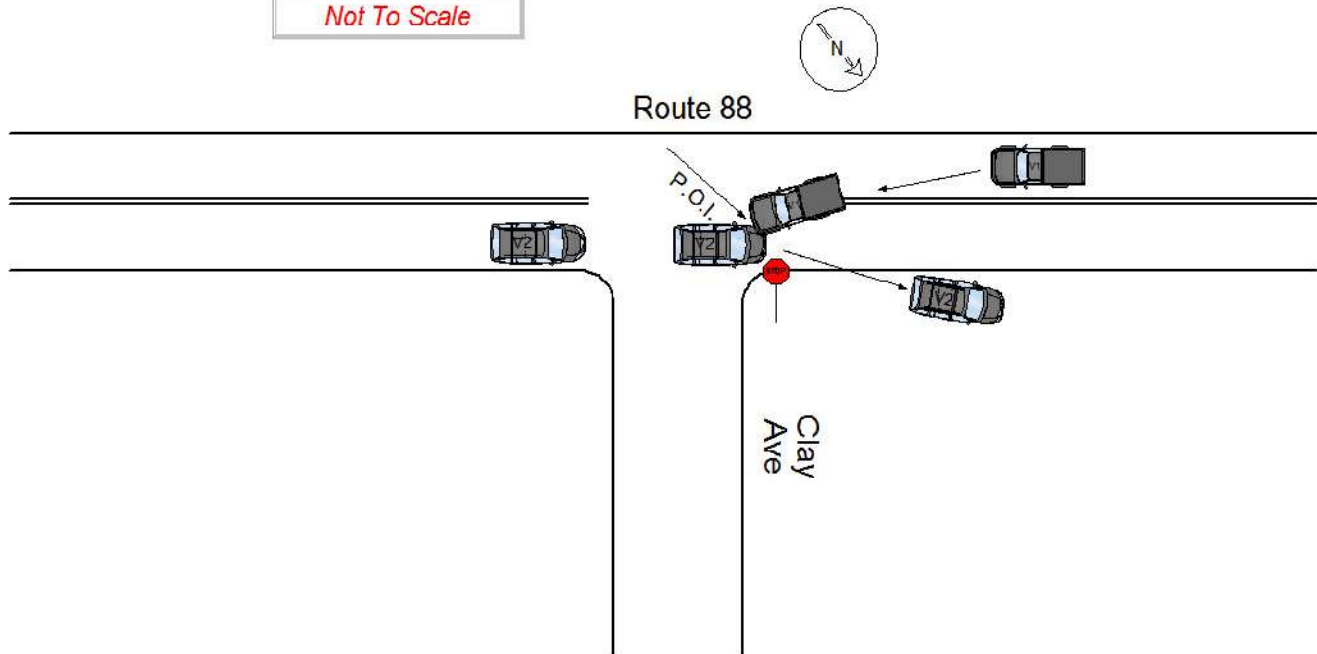
