145. Crash Description/Narrative

Vehicle #2 and Vehicle #3 were both stopped in traffic at the red light at the intersection of Route 70 and Van Zile Road in the inside lane. Vehicle #1 was traveling directly behind Vehicle #2. Vehicle #1 collided with the rear end of Vehicle #2, causing the front of Vehicle #2 to collide with the rear of Vehicle #3.

Driver #3 advised she was stopped at the red light when she was suddenly struck in the rear by Vehicle #2. Driver #2 advised that she was stopped behind Vehicle #3 at the red light when she heard a vehicle screeching and sliding behind her. Driver #2 explained that Vehicle #1 was almost able to come to a complete stop, and merely tapped her rear end initially. She stated Vehicle #1 then suddenly accelerated forward and struck her vehicle hard in the rear before stopping again. Both Driver #2 and Driver #3 stated Driver #1 appeared to be under the influence of something.

Driver #1 was completely incoherent, and would not answer any questions initially. He repeatedly nodded off while sitting in the driver seat of Vehicle #1, and refused when instructed to turn off or exit the vehicle. Driver #1's eyes were watery, blood shot, and pin point, indicating possible alcohol and opiate use. He was subsequently escorted from the vehicle and arrested for Driving While Intoxicated, Possession of Heroin, and

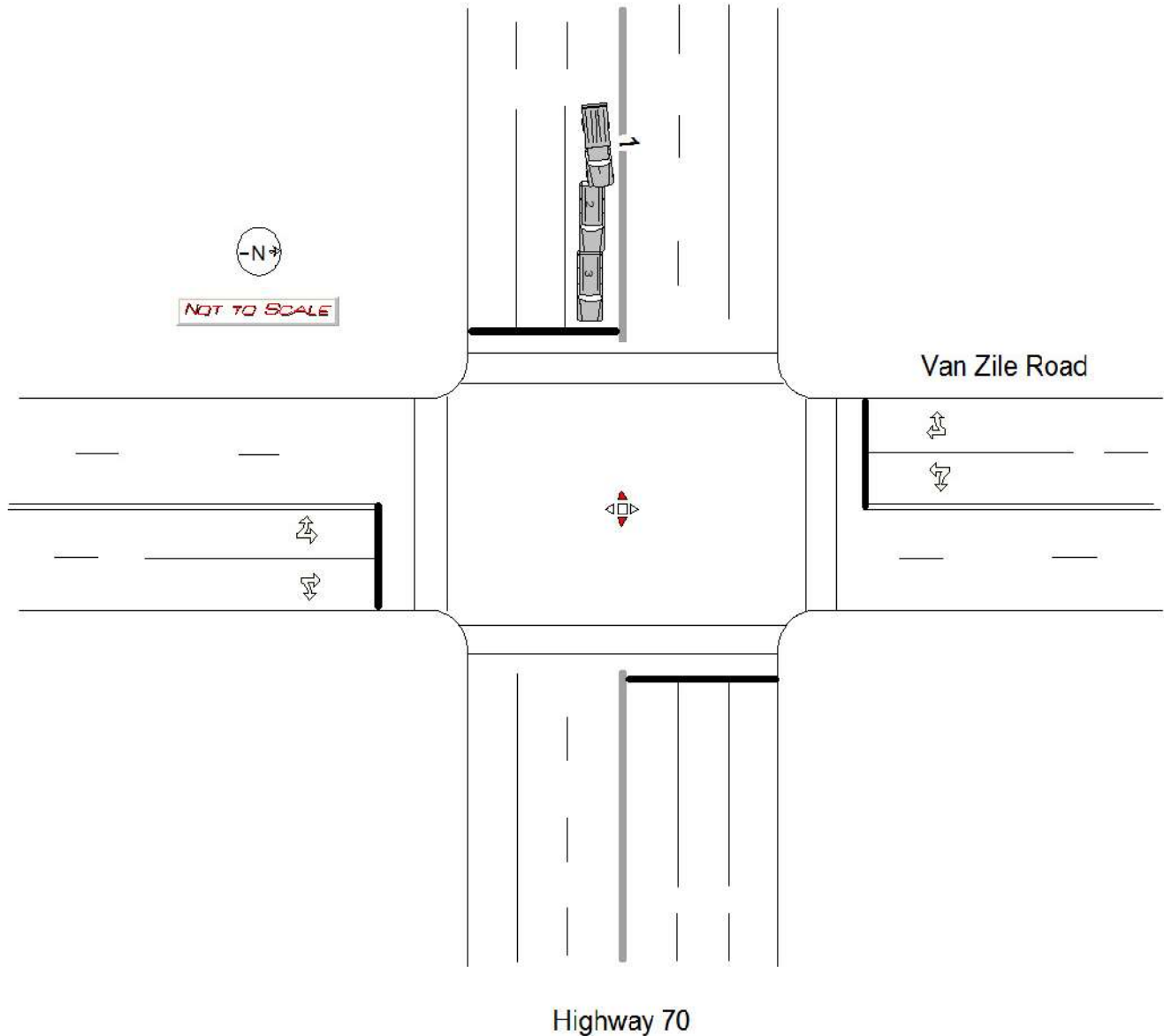
