145. Crash Description/Narrative

Investigation at the scene indicated the following. Vehicle 1 traveled on Route 70 westbound, in the right lane.

Vehicle 2 traveled westbound on Route 70 in the right lane in front of vehicle 1. Vehicle 2 was starting and stopping due to heavy traffic on Route 70. The driver of vehicle 1 did not stop in time and hit vehicle 2 in the rear bumper, which caused minor damage.

I spoke to driver 1 at the scene. She stated that she let her foot off of the brake which caused her to hit the vehicle in front of her.

I spoke to driver 2 at the scene. She stated that the traffic was heavy and was stop and go. As she was stopping in traffic she felt the vehicle hit her from behind.

Due to statements made and damage at the scene, it was determined the driver of vehicle 1 was at fault.

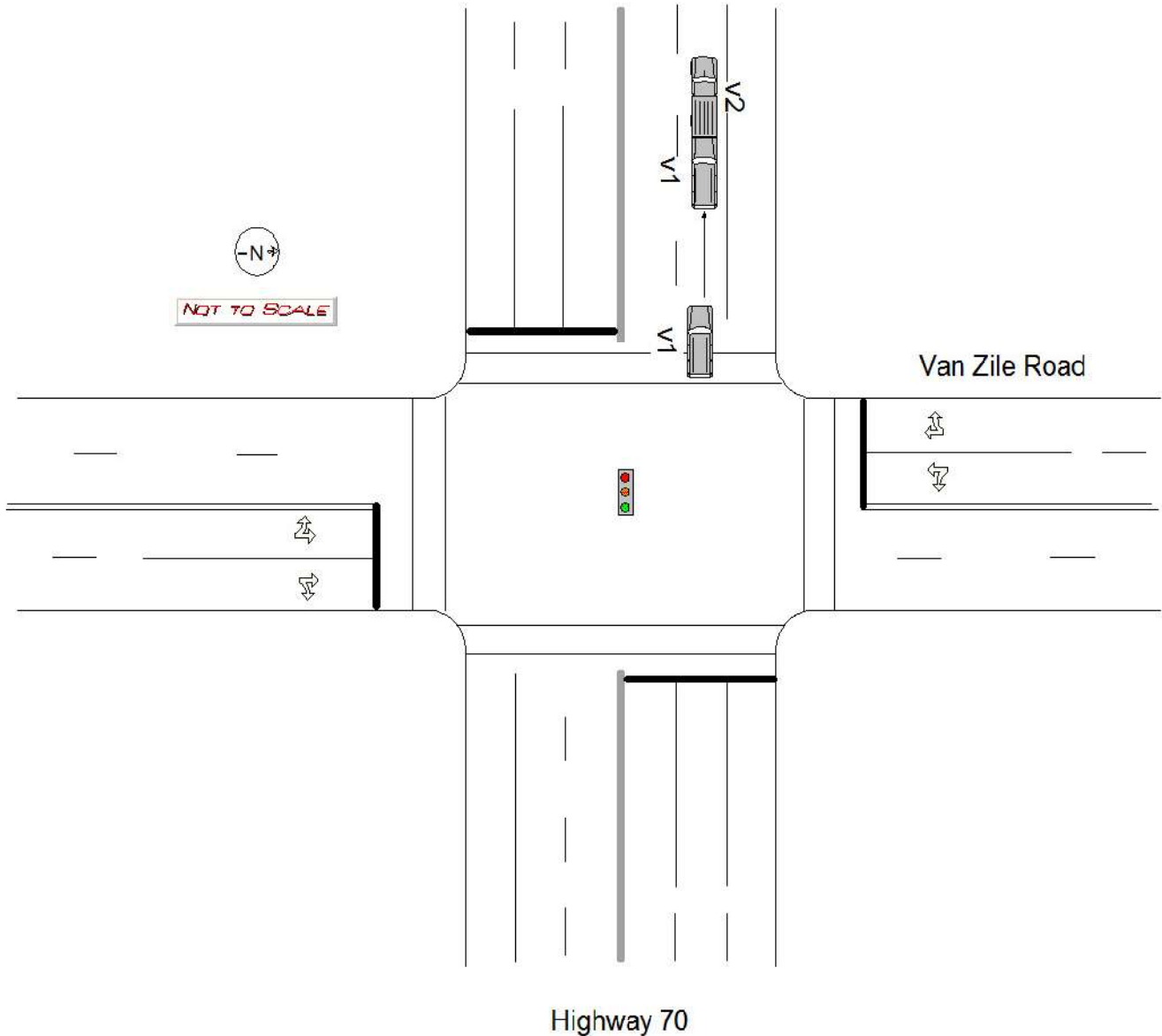
