Driver 1 stated he did not see Vehicle 2 behind him because of the rain.

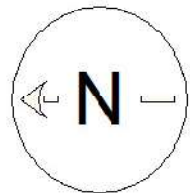
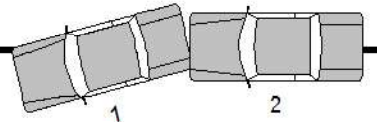
