145. Crash Description/Narrative

Vehicle 1 was traveling west on Route 88 in the area of Brentwood Avenue. Vehicle 1 left the road to the right, ran up a stone retaining wall at the entrance of 1450 Route 88, reentered the roadway and rolled over multiple times prior to coming to final rest. The seatbelt for the Driver of Vehicle 1 was locked in place with no slack, revealing Driver 1 was not wearing a seatbelt at the time of the crash.

Driver 1 stated the following: he was traveling west on Route 88 in the area of Brentwood Avenue when he lost control of his vehicle. The vehicle left the road to the right, ran up a stone retaining wall, and rolled several times. He then climbed out the passenger window when the vehicle came to a stop.

Vehicle 1 had not been moved prior to my arrival. Driver 1 was bleeding and had a complaint of pain in his head, and was transported to Ocean Medical Center for treatment by Brick Police EMS. Vehicle 1 was towed by Lepore's. It should be noted Driver 1 was unable to provide an insurance card for Vehicle 1. Driver 1 was issued the following summons:

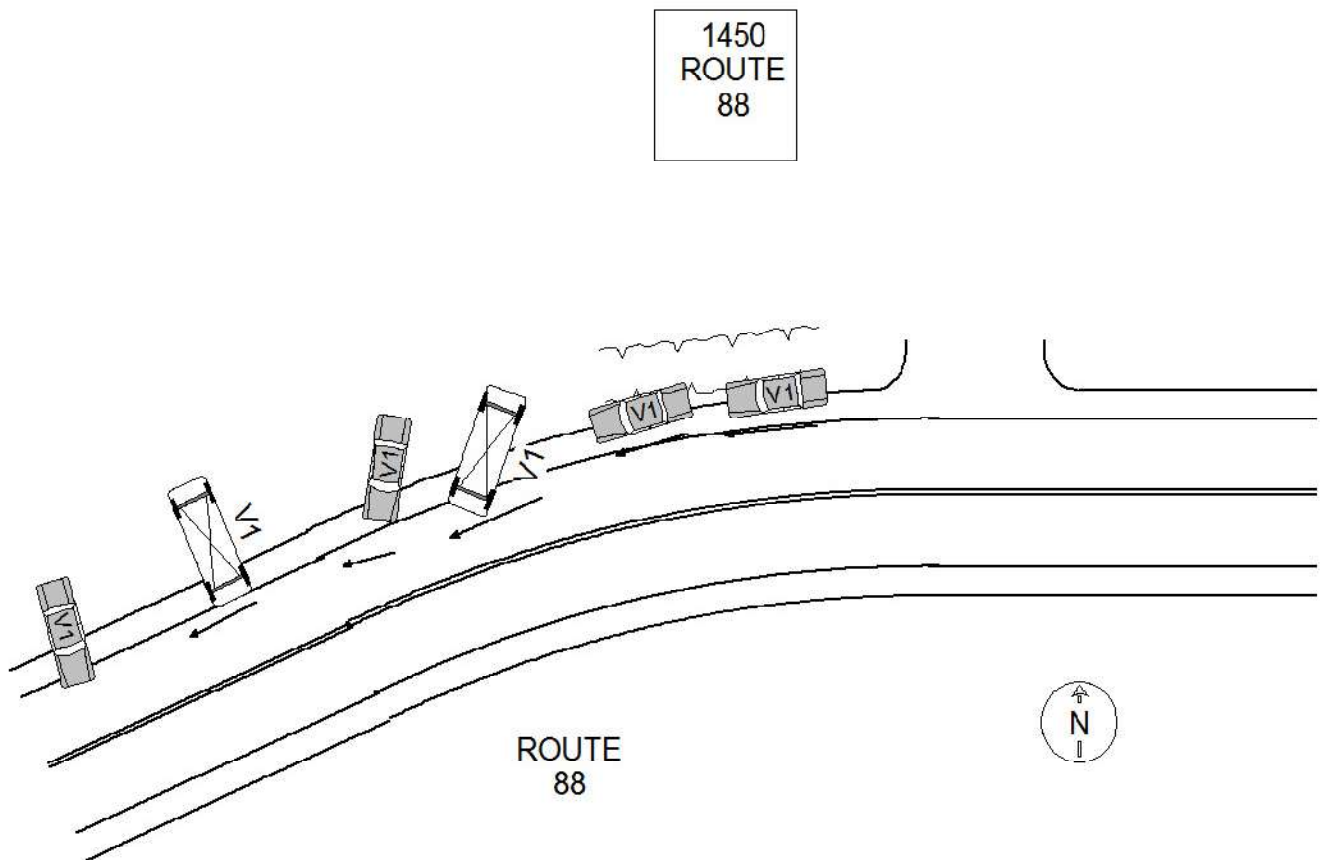
