145. Crash Description/Narrative

Vehicle #1 backed out of the driveway of 1600 Fort Street. Vehicle #2 was parked across the street facing south in front of 1599 Fort Street, approximately 150 feet south of W. Princeton Avenue. Vehicle #1's rear bumper struck the passenger side door of Vehicle #2.

The driver of Vehicle #1 stated she backed out of her driveway and struck the passenger side door of Vehicle #2 with the rear passenger side bumper. The driver of Vehicle #1 stated she is not used to a vehicle being parked in the roadway behind her driveway.

I spoke to the subject who parked vehicle #2. She stated she came outside and observed the vehicle had been struck on the front passenger side door panel.

Based on my investigation and the statements made by both parties, Vehicle #1 shall be at fault for the accident for backing unsafely.

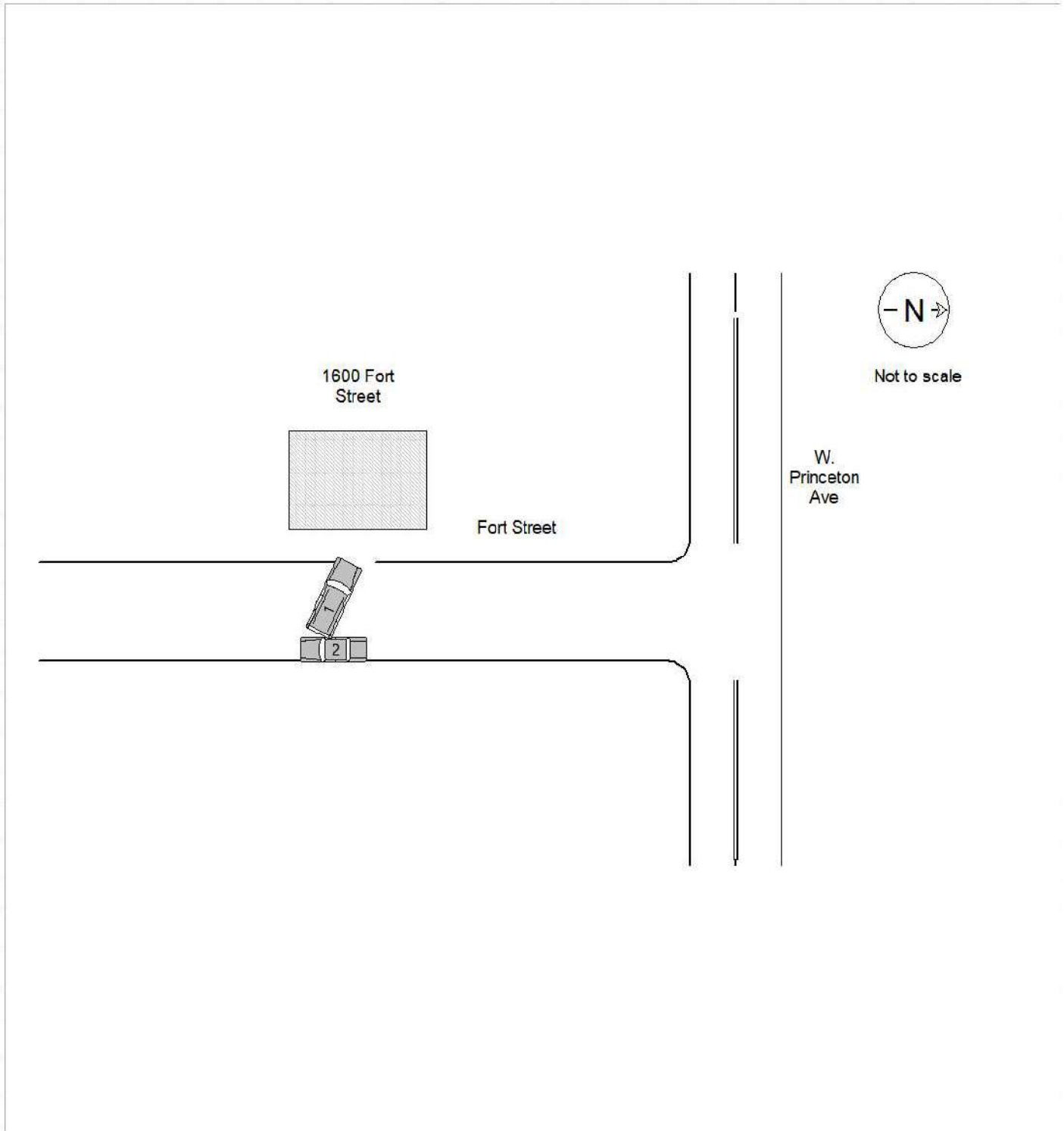
