145. Crash Description/Narrative

Vehicle #1 was waiting to make a right out of the parking lot of Jersey Mike's Subs. Vehicle #2 was stopped in traffic in the Eastbound lane of Rt. 88 waiting to make a left into the parking lot of Brick Tile and Stone.

The front end of Vehicle #1 collided with the rear end of Vehicle #2, causing minor damage.

Driver #1 advised that he was looking at traffic to his left waiting to merge onto Rt. 88. Driver #1 further stated he made a right out of the parking lot of Jersey Mike's Subs and did not see that Vehicle #2 was stopped in front of him. Driver #2 advised that she was stopped in traffic waiting to turn into the parking lot of Brick Tile and Stone when she was suddenly struck in the rear by Vehicle #1.

Based upon my observations, and statements made by both drivers, I find Driver #1 at fault for causing the collision.

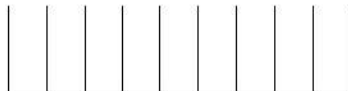
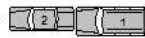
