145. Crash Description/Narrative

Vehicle#1 was traveling East on Route 88 in the left lane. Vehicle#2 was traveling West on Route 88 in the right lane. As Vehicle#2 entered the interchange, from Route 88 West onto Route 70 West, Vehicle#1 continued through the intersection from Route 88 East towards Princeton Ave. South. As Vehicle#2 passed through the intersection it was struck by Vehicle#1. Driver#2 stated that he had the green light and as he passed through the intersection he was struck by Vehicle#1. Driver#1 stated that she was not sure if her light was green or red. she and her passenger were distracted by her GPS. A witness who was behind Vehicle#2 remained on scene and advised that Vehicle#1 ran the light and that she and Vehicle#2 had a green light. Driver#1 was determined to be at fault. Driver#1 sustained a wrist injury to her left hand but refused first aid. Passenger#1 was uninjured. Driver#2 refused first aid. Passenger#2 complained of foot pain in her left foot but refused first aid. Vehicles were not moved prior to arrival.

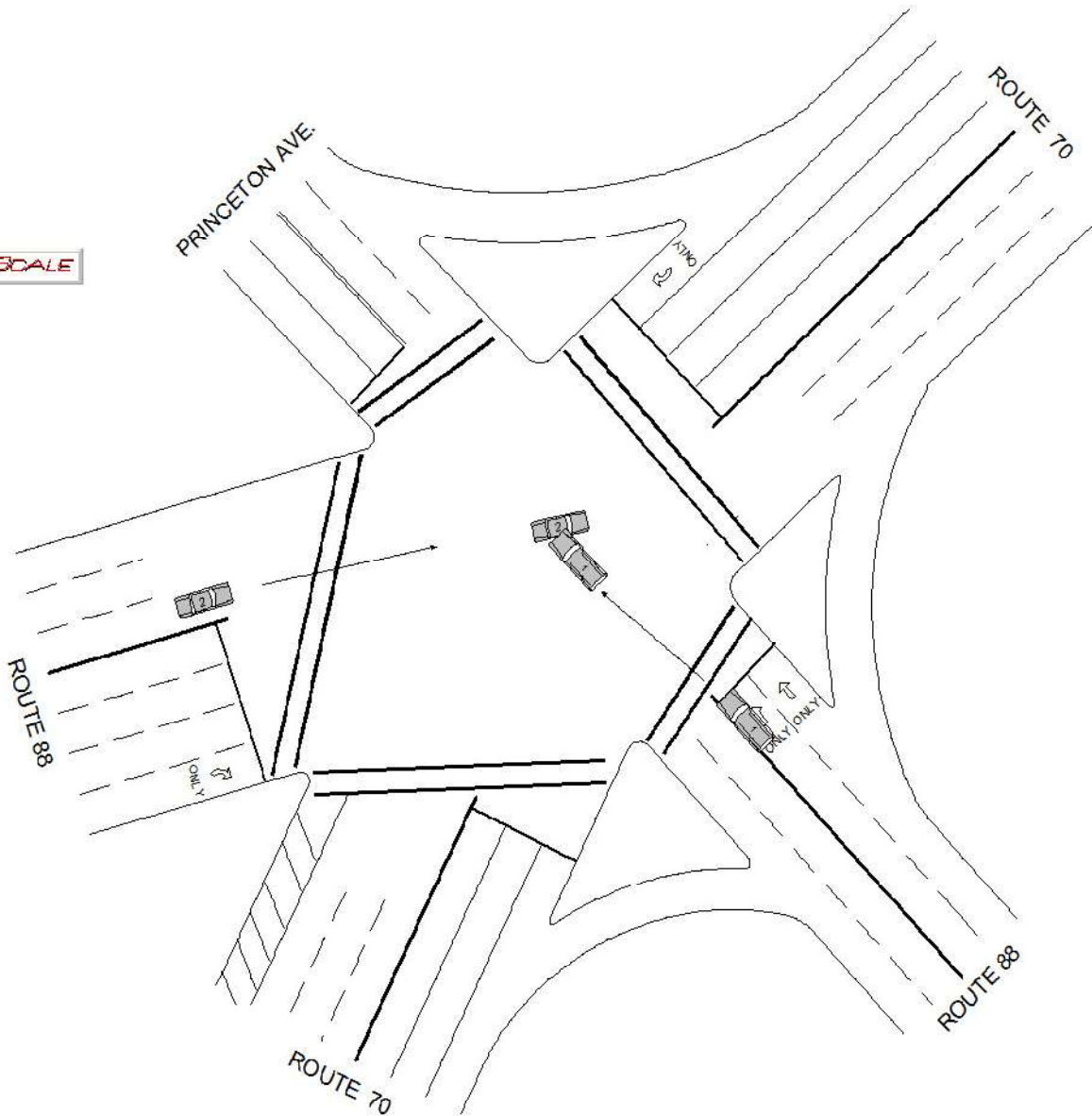
