145. Crash Description/Narrative

Vehicle 1 was traveling north bound on Jordan Rd. approximately 600 feet north of Waters Edge Ct. when it left the right side of the roadway, struck several bushes and into a ditch. After the crash the driver and passenger exited the vehicle and fled the scene as the vehicle was now disabled in the ditch.

After Driver 1 was located sometime later, he stated that while driving on Jordan Rd. he and his rear center passenger where involved in a heated verbal argument. During the argument the passenger began to punch him in the head several times which resulted in him loosing control of the vehicle, leaving the roadway and crashing into the ditch. He also stated that it was "dumb" to continue driving and not pull over when the passenger began to hit him.

Driver 1 was found to be at fault for the crash as he had continued to operate the vehicle while being involved in a physical altercation with the passenger. He was issued the following summons, #E19003865 for Careless Driving 39:4-97, E19003866 for Leaving the Scene of Crash 39:4-129b and Failure to Report a Crash 39:4-130. No injuries we reported at this time.

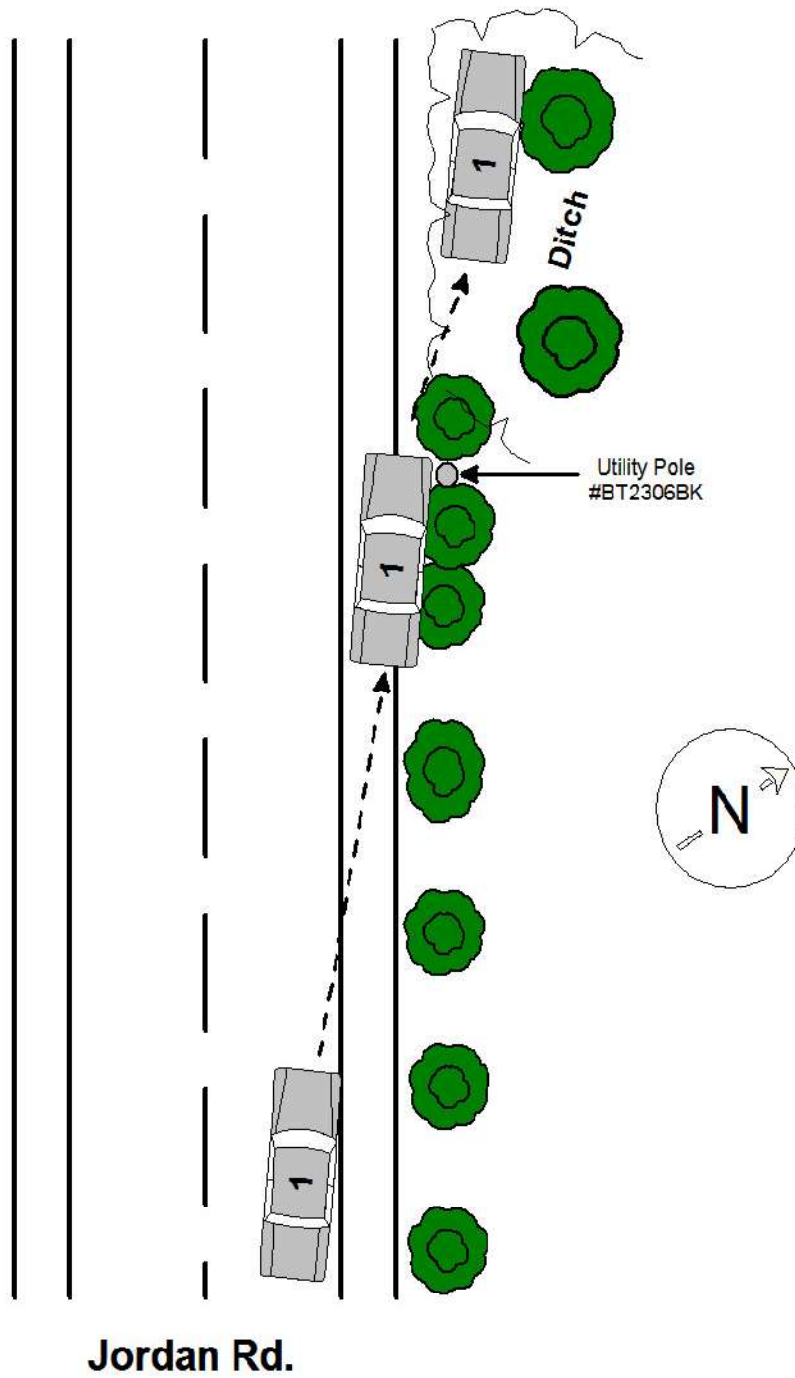
