145. Crash Description/Narrative

Vehicle #1 was traveling west on Olden Street approaching the intersection of Olden St/Rt. 88. Vehicle #1 then

traveled off of the road right and struck a section of shrubbery before striking a tree and coming to a complete

stop.

Driver #1 stated that she was traveling on Olden St. towards Rt. 88 when she looked down and when she looked back

tree because of the wet roadway and struck the tree.

After my investigation I have determined that Driver #1 is at fault for the incident.

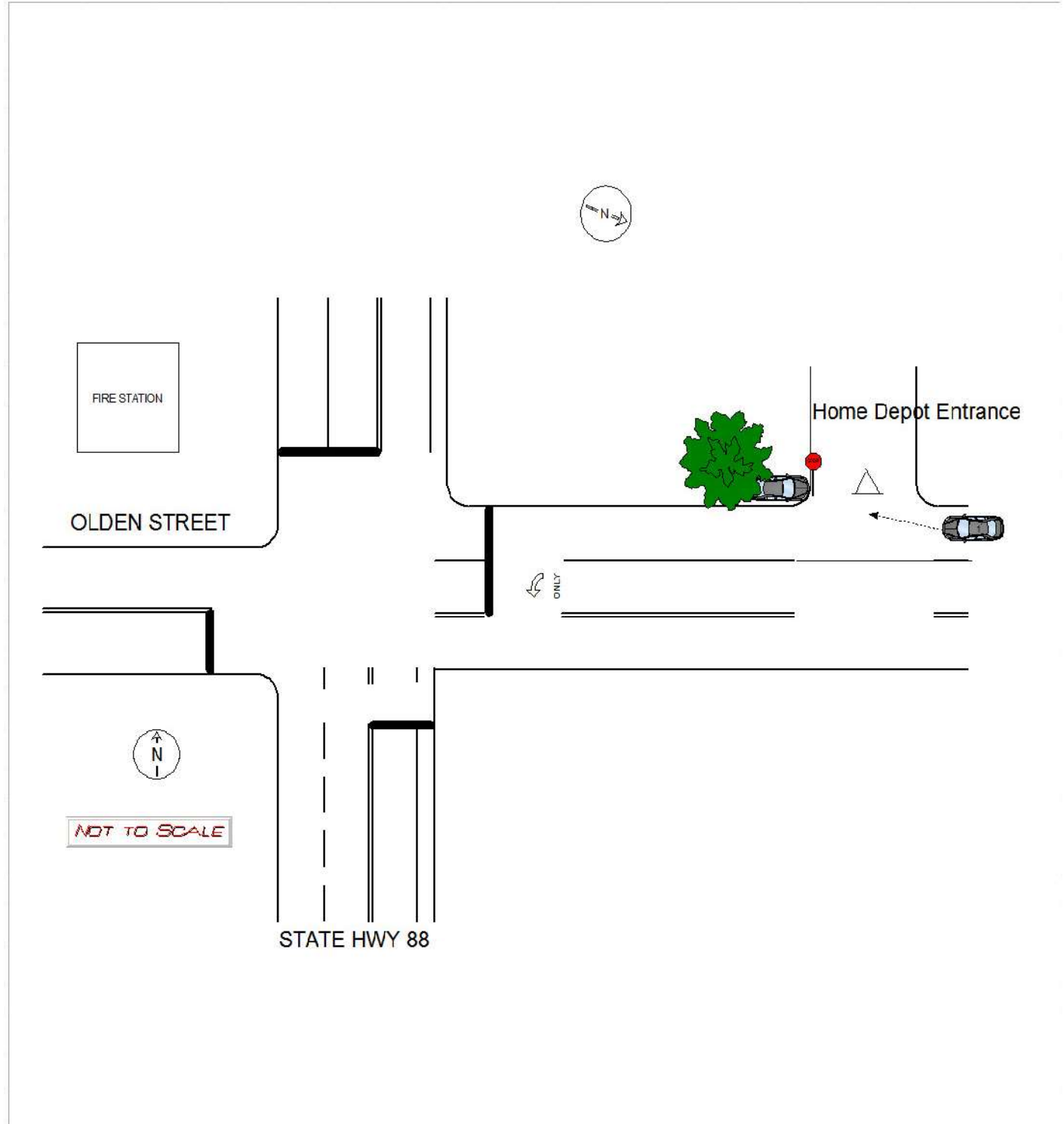
